# **DECATUR PUBLIC LIBRARY BOARD OF TRUSTEES**

**Regular Meeting**

**February 16, 2006**

## **I. CALL TO ORDER**

Eugene King, President, called the meeting to order at 4:33 p.m. Members present: Mr. King, Ty Cocagne, Garry Davis, Shirley Moore, and Patricia Greanias. Absent: Linda Rowden, Carol Craig, Sally Krigbaum, and Nicholette Rademacher. Staff present: Lee Ann Fisher, Scott Pointon, Kathy Collett, Nancy Rostek, and Monica Skelley. Also Present: 2 representatives of AFSCME and reporters from WCIA and the Herald and Review.

## **II. APPROVAL OF MINUTES**

Mrs. Moore moved that the minutes of the January 19, 2006 meeting be approved as presented. The motion was seconded by Mrs. Greanias and was unanimously approved.

## **III. COMMUNICATION FROM THE PUBLIC**

Ms. Fisher presented a letter from Secretary of State Jesse White's office announcing a Per Capita Grant award to DPL of \$100,810.59. She explained that this was about a 2% decrease from last year's award.

## **IV. CITY LIBRARIAN'S REPORT**

The City Librarian's written report was previously mailed. Ms. Fisher added that she had nothing else of significance to report. Mr. Davis complimented the library's website. Mrs. Greanias inquired about the public reaction to the relocation of large print materials. Ms. Fisher explained that there was an initial burst of comment cards and that she had personally written each person to thank them for their concern and explain the situation.

## **V. REPORTS OF COMMITTEES**

### **Personnel, Policy, and Public Relations Committee:**

Mr. Davis reported that the Personnel Committee did not meet in February.

### **Finance and Properties Committee:**

Mr. Cocagne reported that the Finance Committee did not meet in February. The monthly expenditures and financial statement for January were reviewed. Mr. Cocagne noted the ILL payments and legal fees. Ms. Fisher explained that the ILL payments were for materials borrowed through inter-library loan from other libraries for our patrons, who then lost or damaged those items. She added that the legal fees were in conjunction with the recent union contract negotiations and assorted grievances. Mr. Cocagne moved to approve the bills as presented. Mrs. Greanias seconded and the motion carried unanimously by roll call vote. Mr. Cocagne noted that the YTD Budget reflects that overall Library spending is slightly ahead of budget for this time of the fiscal year.

**Rolling Prairie Library System:**

Mrs. Greanias reported that the RPLS Board did not meet in February.

**Friends of the Library:**

Ms. Fisher reported that the FOL "Friend-Raising" event on Thursday February 9<sup>th</sup> went very well. The Friends earned about \$180 selling books and \$650 in contributions were given to the capital campaign that evening.

**Foundation:**

Mr. King noted that the Foundation Board will next meet in April.

**VI. SERVING OUR PUBLIC: STANDARDS FOR ILLINOIS PUBLIC LIBRARIES**

*Chapter IV: Collection Management* was reviewed and Ms. Fisher noted that the library overhauled the DPL Collection Development Policy in 2005 and we subsequently meet or exceed all of the relevant State standards.

**VII. OLD BUSINESS**

At 4:44pm Mr. Davis made a motion that the Board go into closed session to discuss union contract issues. Mrs. Greanias seconded the motion and it passed unanimously by roll call vote.

At 5:04pm Mrs. Greanias made a motion that the Board come out of closed session. Mr. Cocagne seconded the motion and it passed unanimously by roll call vote.

The public attendees were invited back into the Board room by Mr. Pointon at 5:04pm.

Mr. Davis made a motion to approve in substance the union contract that has been negotiated with assistance from the Federal Mediation and Conciliation Service pending Library administration's final approval of wording. Mr. Cocagne seconded the motion and it passed unanimously by roll call vote.

**VIII. NEW BUSINESS**

Mr. Cocagne inquired about how new/replacement Board members were recruited. Ms. Fisher explained that it was the Board's tradition that any exiting member find a suitable nominee to replace themselves on the Board.

**IX. ADJOURNMENT**

Mrs. Greanias made a motion to adjourn. Mrs. Moore seconded the motion and it carried unanimously. Mr. King adjourned the meeting at 5:07 p.m.

**CITY LIBRARIAN'S REPORT**  
**March 6, 2006**  
**DECATUR PUBLIC LIBRARY BOARD OF TRUSTEES**

**CITY LIBRARIAN:** We have had several good articles in the H & R this month, as our programs keep attracting interest. In addition to my regular meetings, I met with Carol Watson of WSEC. I was asked by the Chamber to sit on a committee to look at revamping the Decatur Leadership Institute. I am once again serving on the Youth Development disbursement committee for the United Way, which meets nearly every Tuesday till April 4<sup>th</sup>. Someone suggested I be "locked up" on March 22<sup>nd</sup> for Muscular Dystrophy (donations gratefully accepted). I have spoken to several groups this month and co-hosted two of our outstanding programs. I continue to work with Ed and the union on the remaining contract issues.

**FOUNDATION:** Scott is still submitting grants to various foundations and organizations. Shirley, Scott and I have been speaking to local groups about the project.

**PROJECT NEXT GENERATION:** PNG has used the new Gates laptop computers for their weekly sessions. The mentors are focusing on basic computer proficiency in order to prepare the students for the digital photography sessions that will begin in March.

**RPLS/SIRSIDYNIX:** Nearly every division head, as well as other staff are members on one of the various committees of the RPLS users group. Lee Ann Fisher-Governing Board, Scott Pointon-Finance, Robyn Hendricks-Policy, Matt Wilkerson and John Wylder-Technology and Robert Edwards-Database and Serials. It is important that we be represented on all the committees, so that we can voice our issues and concerns with the system and policy and be aware of what is going on. A recent problem with circulation statistics, found by DPL, was discovered to really be a cataloging problem. By having someone on each committee, we are able to get the "big picture" and how it affects DPL.

**STAFF:** Chad VanDolah has accepted the position of ½ time building custodian and will begin work March 6th. On February 20<sup>th</sup> Chay Williams started work as our newest Adult Division ½ time Page. There are no vacant positions pending at this time.

**ADMINISTRATION:** Total DPL circulation for February was 51,166 as compared to 53,040 in February of 2005 for a difference of -3.5%. The gate count was 29,835 this month as compared to 27,821 in February 2005 (or +7.2%). The YTD total is 277,385 (+1.1%). Our professional assists for the month of February were +5.8% above the same period last year. Our YTD total is +7.0% over last year at this time. The meeting rooms had 14 outside bookings and earning \$580. Scott has been attending the Chamber Breakfast monthly.

**ADULT DIVISION:** The tax program is going well with DOVE, we will have the numbers at the end of the program, but they are currently running about 15% above last year. Displays were set up to complement our programs. We had 5 programs that were attended by 270 people. We gave 2 tours to groups with 37 guests. Our 733 online book club members accessed it 14,880 times last month. The Local History Room had 119 visitors and 24 were from out of town. Brian Looker attended "Spanish for Librarians" and a "Diversity Workshop" this month.

**BUILDING DIVISION:** We rented a high lift so we could replace all the lights, paint the walls, clean all the windows and sills, clean the light panels and replace several bad ballast in the center atrium. Hopefully those lights and repairs will last a few years before needing to be done again, as getting the high lift in here was an ordeal and damage some carpet that we had to replace and repair. We had our annual chiller inspection and maintenance performed and all was well. Also we had an eddy current test performed and it also tested fine.

**CHILDREN'S DIVISION:** On March 3<sup>rd</sup>, WILL sponsored Clifford the Big Red Dog (our John Schirle in costume) drew over 300 people to the Children's room. Staff is participating in the upcoming "Macon County Reads and Explores Authors" grant. We will be hosting some parent-child book discussion groups. Our 22 programs had 311 attendees; we had 7 group visits bringing in 95 people and 6 groups used the children's story room.

**CIRCULATION DIVISION:** Based on patron input, we have started notifying patrons earlier about overdue items. Overdue notices have been reduced to two, the first at 5 days past the due day, the final notice showing the cost of the item at 30 days past the due date. 7,815 items were checked-out of the DPL by patrons from other libraries, 1,664 items were checked-out to DPL patrons at other libraries. We placed 3,425 requests, resolved 5,480 and of these, 2,369 items were picked up here at the DPL. We routed in 1,699 items and routed out 4,056 items to other libraries. 347 new accounts opened in February, down 8% from January, and up 5% from February of 2005.

**EXTENSION DIVISION:** For a change, both bookmobiles are running well. John attended the HSAC meeting and "Spanish for Librarians." We had 21 volunteers donate 150.5 hours of service this month.

**GATES COMPUTER LAB:** We had 103 people attend the 10 different classes we offered. Due to the overwhelming demand, we have instituted new rules limiting patrons to three classes per month. All of our new Gates laptops have a problem related to a certain version of Driveshield. Dave Nelson from Bellcow was here twice to fix them.

**SYSTEMS ADMINISTRATION:** We still have several issues with CybraryN that Matt is working on. There is a problem when releasing more than one print job at a time, the PC's do not shutdown at closing time, and CybraryQ is not keeping session time of 30 minutes, it somehow is changing to 1, 4 or 6 minutes. Also some patrons' getting more than 210 minutes a day. There were 333 work orders received from the staff for this month.

**TECHNICAL DIVISION:** This month a total of 1,573 titles, including 22 items donated to the library were cataloged into the database. Processing mended 1,185 items this month. Cataloging and Processing are both working on special reclassifying projects. Robert Edwards has been accepted into the State's *Cataloging Boot Camp*. The camp will be held during the month of May in Decatur.

**Finance and Properties Committee**  
**March 14, 2006**

Mr. Cocagne called the meeting to order at 4:35 p.m. Members present: Ty Cocagne, Shirley Moore, and Eugene King. Absent: Pat Greanias and Nicholette Rademacher. Staff present: Lee Ann Fisher and Scott Pointon.

**Financial Statements**

The February Check Register was reviewed. Mr. Cocagne inquired about the large check to the Macon County Treasurer. Ms. Fisher said she would look into the reason for that payment. Mrs. Moore asked about the amount of legal fees incurred since the union contract expired. Mr. Pointon explained that the Library's bookkeeper was preparing that information for the upcoming Board meeting on March 16<sup>th</sup>. Mrs. Moore asked what the cost is for our security force. Ms. Fisher responded that the officers earn about \$100 per night, five nights per week. Mr. Cocagne recommended that the check register be presented at the Board meeting on March 16, 2006.

The YTD Budget statement was reviewed. Mr. Cocagne noted that the Personnel Services budget was 80.6% expended and asked about the retro-pay specified in the proposed Union contract. Ms. Fisher explained that once the contract language is agreed upon and the document is signed by the relevant parties, all of the retro-pay paperwork will be submitted to the City. At that point it will be out of our hands as to whether those payments are made this fiscal year or next. Mr. Cocagne noted the budget line reflecting professional services expenditures. Mr. Cocagne inquired about the "Computer Software" line in the budget. Ms. Fisher explained that this is another example of grant expenditures that cannot come from the area of the budget where grant revenues are placed. This is a continuing problem resulting in over-expenditures in several budget lines.

**Old Business**

There was no old business.

**New Business**

Ms. Fisher presented the FY2006-2007 budget. Mr. Cocagne inquired about the amounts budgeted for Medical Insurance, Unemployment, Worker's Comp, and several other areas. In the 2005-2006 budget prepared by Ms. Fisher the amounts in these areas do not equate to the amounts actually allocated to these three areas in the 2005-2006 budget. Ms. Fisher explained that at the time she is preparing the budget, the City gives her figures that allow her to estimate these amounts as closely as possible. She stated that later, when the City makes the actual allocations and creates the budget spreadsheet for next year they will have more information and can thus more accurately place dollar amounts in these budget lines. Mrs. Moore inquired about the amount Ms. Fisher had budgeted for natural gas expenses in FY2006-2007. Ms. Fisher said she would look at that item again and make adjustments where necessary. Mr. Cocagne inquired about the tax rate supporting comparably sized libraries in Illinois. Ms. Fisher said Mr. Pointon could look into that and report back to the Board with the findings. Mrs. Moore inquired as to why the meeting room revenues for FY2005-2006 are not as high as projected. Mr. Pointon pointed out that those predictions are just guesses and that the library has no way of predicting

how often the meeting room will be booked. Ms. Fisher added that the volume of our library programming is likely causing the rooms to be available less often to outside paying customers.

Ms. Fisher presented the materials budget for the coming year, and explained that it equates to about 11% of tax revenues brought in to the Library.

Mrs. Moore made a motion to adjourn. The motion was seconded by Mr. King and the meeting was adjourned at 5:26pm

All Illinois public libraries should provide or contract to provide professional reference service for their patrons. For purposes of this document *professional reference service* refers to reference service provided by a person holding an MLS degree from an ALA-

Reference service is the provision of information in response to a patron's question. Reader's advisory service is guidance in selecting material appropriate to a specific patron's desires and needs.

7. The library provides current issues of at least one community or local newspaper and retains backfiles for a minimum of six months.
8. The library provides access to local ordinances or codes of all municipalities within its service boundaries.
9. The library provides access to local and state maps.
10. The library provides access to the minutes of local government meetings. These include but are not limited to municipal (village, township, or city) and school board meetings.
11. The library provides voter information, including precinct boundaries and location of polling places.
12. The library provides information about local history and events.
13. The library has telephone books for the local calling area and any other frequently requested areas.
14. The library has all materials included in the list of basic reference materials. (See appendix 5.2.)
15. Staff have access to a telephone to receive and respond to requests for information and materials and to contact other agencies for information.

## Evaluating Reference Service

Although reference service is one of the most difficult areas of library service to measure, the exercise of examining and attempting to evaluate reference service heightens the librarian's awareness of what comprises quality reference service, increases the librarian's sensitivity to patron needs, and stimulates efforts to improve. (See appendix 5.3 for evaluation methods.)
