Regular Meeting
April 19, 2007

I. CALL TO ORDER

Eugene King, president, called the meeting to order at 4:30 p.m. Members present: Mr. King, Rene Corcoran, Garry Davis, Shirley Moore, Linda Rowden, Beth Couter, Carol Craig, and Sally Krigbaum. Absent: Nicholette Rademacher. Staff present: Lee Ann Fisher and Karen Bjorkman.

II. APPROVAL OF MINUTES

Mrs. Moore moved that the minutes of the March 15, 2007, meeting be approved as presented. The motion was seconded by Mr. Davis and unanimously approved.

III. COMMUNICATION FROM THE PUBLIC

Jim Bacon, the former city manager, was present and expressed his appreciation for the services the library provides, especially the art exhibit. He also made favorable comments on the recent article about the Decatur Public Library that was in the Herald & Review.

IV. CITY LIBRARIAN'S REPORT

The City Librarian's written report was included in the packet. Ms. Fisher presented information concerning the library's upcoming program in the park on May 20, 2007. The patriotic celebration in the park is on the last Sunday the library is open until September.

V. REPORTS OF COMMITTEES

Personnel, Policy, and Public Relations Committee:

Motion by Mr. Davis to approve the new "Computer Use and Internet Access Policy" and to have it take effect on June 1, 2007. Seconded by Mrs. Couter. Motion carried unanimously.

Finance and Properties Committee:

Mrs. Couter moved to approve the March check register as presented. Mrs. Moore seconded the motion and it was carried unanimously by roll call vote.

Rolling Prairie Library System:

The new sensitizer/desensitizer machine will allow the Friends to use one of the old ones to check materials on the book sale.

The city is fighting a workman's comp claim that was filed by a circulation clerk. Two members of the library staff have agreed to testify on behalf of the library.

CITY LIBRARIAN: April is always a busy as you tie up the old year and prepare for the new one. The new Video Game collection was made available and has been very well received. There is rarely a game in, but patrons seem very willing to place requests. The last Sunday hours will be May 20th, and will begin again on September 9th. In addition to my regular meetings, I visited the Merchant Street Lofts, finished my United Way obligation, interviewed several candidates for the reference position, manned the DPL booth at Johns Hill for their family literacy night and met with several people to discuss library issues. I was on vacation April 5-9.

FOUNDATION: Patrick McDaniel has agreed to serve on the board; we still have one position to fill. We are waiting to hear from the NEH before we schedule our next meeting, so we can discuss the results. I have followed up on several leads concerning possible donors to the capital campaign.

FRIENDS: The "Second Saturday Sale" grossed \$922 in March, one of their best months yet. The Friends will once again support the summer reading program, by buying books as rewards and the latest Harry Potter book and t-shirts as prizes. They also approve buying Circulation 4 new book carts and a book check machine.

PNG: An average of 9 students attended each session in April. The students have been enthusiastic about making their web pages mostly because of the My space popularity. The last meeting date has been set for May 16th and we will take a break for summer. I will be sending our intent to participate in PNG to the state before May 15th.

RPLS/SIRSIDYNIX: Rene has been approved to replace Garry as our representative to the RPLS board. Robert Edwards is preparing the cataloging staff to take the barcoders exam as mandated by the State Library and which he has assisted RPLS in developing the tutorial for. If you don't pass, you can't catalog.

STAFF: The page list had run out, so the position for a part-time page has been posted by the city in the paper. The test is scheduled for May. Additional interviews were conducted for the reference librarian position and Amy Hanaway will start on May 29.

ADMINISTRATION: Karen and Rhalo set up and manned 2 exhibits for the library one at Richland College and the other at Hickory Point Mall. The meeting rooms were booked 24 times earning \$710 in fees. Karen attended Library Legislative Day at the state capital.

ADULT DIVISION: The teen summer reading contest will be based on the 80's arcade and videogame, Space Invaders to go along with our Children's space theme. We received several glowing reports for our Jazz series and each program was well attended. Our 8 programs had a total attendance of 378. The 11 online book clubs were accessed 18,860 times and they have 943 members. The Local History room had 80 visitors, 18 from out of town. This department is still down a librarian and 2 pages.

BUILDING DIVISION: Due to continued vandalism in the bathrooms, we are testing some automatic towel dispensers. We have patched several holes in the parking lot. The generators on both bookmobiles continue to have intermittent problems. The tower and the chiller are up and running for the AC some of the smaller blowers that are not circulating air and are waiting on parts.

CHILDREN'S DIVISION: Susan led the final book discussion groups on this year's Caudill winner. This has been a very successful program and plans are being made to continue it in the fall. The Summer Reading Program starts June 1 with "Mission Read... to the Library and beyond!" Alissa has joined the Society of Children's Book Illustrators and Writers. We offered a total of 15 programs, attended by 243. We spoke to 11 groups with 200 listeners, 6 groups used the children's room this month and 407 signed up to use the computers.

CIRCULATION DIVISION: The total number of checkouts during the month of April was 42,673 items, down -8% as compared to the 43,800 items checked out in March 2007, and up +3% when compared to 39,225 items checked out in April 2006. There were 6,558 items checked out of the DPL by patrons from other libraries and DPL patrons checked out 4,185 items at other libraries. Of the 4,743 items checked out by our patrons at other libraries, 2,243 of those items were checked out on the bookmobiles. We had 1,860 items routed into the DPL from other libraries to fill requests and 4,481 items were routed out of the DPL to fill requests. We placed 4,414 requests in April, down -3% from March and up +30% from last April. We resolved 6,485 requests and of these, 3,164 items were picked up here. We had 268 new accounts opened in April, down -20% from March 2007, and down -9% from April 2006. 387 expired accounts were deleted. New library accounts are down -14% overall from 2006 at this time

EXTENSION DIVISION: The generator problems caused us to miss some stops, but we ran on battery power when we could to keep this to a minimum. John is working on the summer schedule; we still have several stops pending. We had 19 volunteers donate 147 hours this month.

GATES COMPUTER LAB: The Lab was closed April 17 – 19 to allow our PCs to be swapped out and replaced with laptops. The laptops have keyboards and mice attached for those who have trouble using them. We had 64 people attend one of our 12 computer classes offered.

SYSTEMS ADMINISTRATION: We are working with the city and the Downtown Decatur Council putting a webcam on the Transfer House, so people can watch its progress (<http://www.downtowndecatur.com/>). Matt spent most of the month working on putting laptops in the lab and reconfiguring the old pc's for other locations within the library. The department had 238 work orders.

TECHNICAL DIVISION: Acquisitions processed 546 invoices, received and sorted 25 bins of mail, and 79 packages. Ordering was slowed down due to the annual freeze on spending. We had 155 interlibrary loan requests from our patrons and filled 86% of them. There were 612 OCLC request and 47% were filled. Cataloging and Acquisitions are preparing for the Barcoders Certification exam required by the State Library. We cataloged 882 titles; including 176 donated items and 202 items were reclassified. We withdrew 701 titles from the collection and reinstated 16 titles. There were approximately 9,709 database changes, imported 495 new records into the Horizon database, and did item work on 1,127 new or added copies. Robert, Lee and Kathy attended an IOUG Audiovisual Media: Video Cataloging workshop on April 24. We processed 666 periodicals as well as 168 paperbacks. Mending accounted for 1,140 items by the Processing staff. 31 books were sent to the bindery this month. Reclassifications accounted for 362 items and staff security taped 83 DVD cases.

Chapter VII Access

Access refers to the ease with which all residents can use the library. Some of the factors that affect access are hours of service; quality of cataloging; the physical facility and distance to the physical facility; the quantity, quality, relevance, formats, and arrangement of the collections; quality and quantity of staff; public relations; policies on use of collection and services; and availability of collections and services outside the library. The extent to which the library uses existing and emerging technology to provide in-house as well as remote access is an additional factor. While existing budget limitations may prevent immediate use of some technology, it is important that those responsible for long-range planning keep current on products and services so that informed decisions can be made if funding becomes available.

Standards that relate directly to the building or “fixed assets” such as lighting and furniture are included in chapter VIII, Facilities.

Applicable Core Standards

- Core 1.** The library provides uniformly gracious and friendly service to all users.
- Core 3.** The library is in compliance with all other state laws that affect library operations including but not limited to the *Illinois Accessibility Code* [ILL. ADMIN. CODE tit. 71, § 400 et seq.], the *Open Meetings Act* [5 ILL. COMP. STAT. ANN. 120/1], the *Illinois Freedom of Information Act* [5 ILL. COMP. STAT. ANN. 140/1 et seq.], the *State Records Act* [5 ILL. COMP. STAT. ANN. 160/1 et seq.; 70/2 and 5/1-7], the *Library Records Confidentiality Act* [75 ILL. COMP. STAT. ANN. 70/1] and the *Drug Free Workplace Act* [30 ILL. COMP. STAT. ANN. 580/1 et seq.].
- Core 4.** The library is in compliance with all federal laws that affect library operations including but not limited to the *Americans with Disabilities Act* [42 U.S.C. 12101 et seq.], the *Fair Labor Standards Act* [29 U.S.C. 201 et seq.] and the *Bloodborne Pathogens Standard* [29 C.F.R. § 1910.1030]. (See appendix 1.)
- Core 12.** The library has a board-approved mission statement, a long-range plan, a disaster prevention and recovery plan, and policies. Such policies include but are not limited to the following topics: personnel; reference; use of the library’s materials, services, and facilities including use of the library for exhibits and meetings; and collection management. Illinois statutory law specifically requires the board to establish and review at least biennially a written policy for the selection of library materials (as part of the library’s collection management policy) and the use of library materials and facilities [75 ILL. COMP. STAT. ANN. 5/4-7.2 or 75 ILL. COMP. STAT. ANN. 16/30-60]. All library policies are in compliance with state and federal laws. (See appendix 2.2.)
- Core 16.** The library adopts and adheres to the principles set forth in the American Library Association’s *Library Bill of Rights* and other ALA intellectual freedom statements and interpretations. (See appendices 2.4-2.6 for ALA *Library Bill of Rights* and other ALA intellectual freedom statements.)

- Core 19.** The library is a member of an Illinois multitype library system and participates in resource sharing through interlibrary loan and reciprocal borrowing.
- Core 20.** The library has a telephone, telefacsimile machine, photocopier, and computer with modem. The library provides telephone service to its patrons with hearing disabilities through a TTY (teletypewriter), TDD (Telecommunications Devices for the Deaf) or a voice relay provided by the telephone company.
- Core 21.** The library provides access to ILLINET Online.
- Core 24.** The library is open a minimum of 25 hours per week. The hours, scheduled for the convenience of the public include a minimum of two evenings (total of 6 hours after 5 p.m.) and 4 weekend hours. Branches or other fixed service points, but not bookmobiles, are also open a minimum of 25 hours per week.
- Core 27.** The library informs its community about the collections and services available in and through the library.

Supplemental Standards

1. Hours of service are posted on a sign visible to the public from outside the library building.
2. Hours of operation are established for the convenience of the community. To accommodate school children and working adults, the library is open as many evening and weekend hours as possible. (See appendix 6 for recommended hours of service by population.)
3. All basic services are available when the library is open. For the purpose of this document, basic services are circulation and reference and reader's advisory. If reference and reader's advisory are provided to children and adults from two separate points, then the library provides adequate staffing all both locations at all hours the library is open.
4. The collections are arranged and housed in a way that provides the greatest accessibility for all users.
5. Materials are not sequestered from any user except for the purpose of protection from theft and damage.
6. All circulating materials may be borrowed by all persons with a valid library card who reside within the jurisdictional boundaries of the library regardless of the age, sex, or social or economic status of the patron.
7. All materials, except those judged by the library administrator to be irreplaceable or needed in the collection for reference service, are available for use within the library by all persons regardless of the age, sex, or social or economic status of the patron.

8. Lending regulations facilitate maximum use of library materials.
9. The library publicizes and promotes interlibrary loan to its patrons. The library develops procedures that ensure that interlibrary loan is a simple and effective way for patrons to receive materials and information.
10. Accurate and easily understood bibliographic access is provided through a computerized or manual card catalog.
11. The library's bibliographic and holdings information are in machine-readable form using the MARC format.
12. A current record of the library's holdings is available on ILLINET Online.
13. Through clear signage or logical placement, the services, collections, and amenities of the library are easily located.
14. The library ensures access to its collections and services for patrons with disabilities through the provision of auxiliary aids and alternate formats.
15. The library provides access to its collections and services for patrons unable to travel to the library. (Some of the ways to provide this kind of service are deposit collections, programs held in sites outside the library, and home delivery.)
16. Telephone, text telephone, and telefax numbers are listed in both white and yellow pages. The library has sufficient incoming telephone lines for voice and data transmission to accommodate staff and user needs.

Friends of the Decatur Public Library
Proposal for Continuation of Second Saturday Book Store

The Friends of the Decatur Public Library appreciates the support of the Board of Trustees in staging the Second Saturday Book Store to raise funds for the Decatur Public Library. In the original agreement, the Board gave the Friends permission to use the space until October 2006. In order to place publicity in a timely way, the Friends now requests that the renewal agreement approved in May 2006 be extended until September 2008.

Between October 2006 and May 2007, the Friends have raised \$5,713.15 with expenses of \$350, for a net profit of \$5363.15. Our largest revenue from October through May came in March at \$922.50, followed closely in December 2005 at \$886.00. The Friends' monthly goal in our new budget is \$600; our current average is \$710. We continue to build our customer base, with new visitors each month who are amazed that we are able to offer these bargains.

The Friends' financial position in general is healthy. We have in a CD the \$50,000 pledged for the building renovations and an additional CD of \$13,000, both of which will mature in June.

By extending this agreement, the Friends will be able to continue its support of Library and community programs related to literacy and culture. The Summer Reading Program, Baby Talk, and the Library Gardens activity by the Master Gardeners enhance the Library's service to the community.
