

The League of Women Voters of Macon County
Minutes of Board ~~of~~ Directors Meeting
October 22, 1946

President Redmon called the meeting to order in her home with the following members present: Fryxell, Berg, D. Wood, R. Wood, Birks. Temple and Kuhns arrived later.

The minutes of the September meeting were read and approved.

The Treasurer's Report showed our balance on hand to be \$46.70, with a total membership of 55.

President Redmon called for suggestions for Constitutional Convention Chairmanship and Economics Welfare Chairmanship. Mrs. Fryxell moved that Miss Redmon be instructed to ask Mrs. H. Wayne Hill to fill the former Chair and Mrs. Robt. Lewis for the latter, with Mrs. Brock to be asked to take the chair as Education Chairman. Seconded by D. Wood, motion carried.

Mrs. Fryxell brought up for consideration the proposition of faculty wives and G. I. wives who were interested in belonging to the Millikin chapter of the League. She wondered if they should pay dues to our group or if they could come into the Millikin group under their blanket fee. It was finally suggested that she wait until a specific case was presented before we arrived at a decision as it seemed that the case might affect the decision.

Miss Redmon appointed Mrs. Berg to take charge of Radio Publicity under her publicity Chairmanship. She was instructed to appoint her own committee to work under her direction.

Mrs. R. Wood moved that we order 100 copies of "When You Vote", to be mailed to the membership. Second by Mrs. Berg. Motion carried.

Mrs. Fryxell moved that Mrs. Berg be instructed to place a paid advertisement in the Herald and Review, urging citizens to vote wisely, and to make spot radio announcements of it could be obtained without charge. Seconded by Mrs. D. Wood, and passed.

Mrs. R. Wood was instructed to appoint committees to visit the various governmental boards of the city and county.

Mrs. Temple was instructed to arrange for a place for a general meeting at which time Mrs. Wood's committee would report and we would have a speaker on Atomic Energy. She was instructed to see if Dr. Gage of Millikin could be obtained as speaker, or if the Atomic Energy subject was out to consider Int. Affairs.
