League of Women Voters of Macon County

January 14, 1947

The meeting was called to order in the assembly room of the Y. W. C. A., by the President Blossom Redmon. A general business meeting preceded the program for the afternoon. Christine P' Simer gave a short report on the Constitutional Convention meeting which she had attended in Chicago. It was announced that Miss P' Simer would speak to the study groups in detail on the meeting.
