He made five points on the credit side. 1. It will bring a unified trial court system; a great simplification over the present system of courts which is unnecessarily complex and expensive. 2. It will abolish the fee system and "cuspidor justice". Now the JPs and magistrates operate without supervision and are paid fees from cases they try. The plaintiff brings the JP the business, the loser pays the fee in vivil cases. system is a denial of due process. 3. It will improve the jurisdiction of the Supreme Court. 4. It will simplify the taking of appeals. and 5. There will be central administration.

The objections to the amendment are 1. Any change encounters opposition. The article will be jeopardized more by indifference than opposition.

2. Some people will lose their business, the JPs eventually and some judges. 3. The idealists wanted this to be perfect and are disappointed because it does not have a plan for selection and tenure of judges and it violates the traditional separation of powers.

Professor Cleery feels that we will not have another chance within our lifetime to change the judicial system. The opposition voices fear of the legislators but they are just people whom we elected. If this article is going to carry it is because people who think about it talk to others.
