

BOARD MEETING  
May 1, 1952

The Board of Directors of the League of Women Voters of Macon County met at 1:30 P.M. on May 1, 1952, in the Association of Commerce Conference Room with eight members present.

In the absence of the President, Mrs. Clifford Smith, the meeting was called to order by the First Vice-President, Mrs. Gerald Cox, and the minutes of the April meeting were read and approved. The Treasurer reported a balance of \$627.55. Mrs. F. Hanley Brock, the Treasurer, reported 23 members paid their dues, and \$7.00 has been collected for Voters' Hand-Books.

Mrs. Cox stated there will be a meeting in Champaign on May 9th from 10:30 to 3:00 on Constitutional Revision. This meeting will be attended by Mrs. Ruedi, Mrs. Cox, Mrs. Gibson and Mrs. Etheridge. Summaries on the following were given: Judicial Article, Mrs. Lupton; Apportionment and Home Rule, Mrs. Doubleday.

Mrs. Cox reminded the Board the broadcast from the National Convention on "Citizens View of '52", will be tonight from 8:35 to 9:00; televised from 6:00 to 7:00.

"Request for Action" on International Trades and the Defense Production Act and Mutual Security Program were answered by Mrs. Gibson, Mrs. Donovan and Mrs. Pettee. Letters and replies to Congressman Springer were read by Mrs. Gibson. "Request for Action" on "United States Contributions to the United Nations" taken care of by Mrs. Donovan and Mrs. Gibson.

Expenses for Citizens View of '52" of \$72.31 were presented by Mrs. Gibson, Chairman. It was moved by Mrs. Lupton, seconded by Mrs. Wood that this bill be paid. Carried. Bill for membership cards of \$4.85 presented. Moved by Mrs. Lupton, seconded by Mrs. Wood that this bill be paid. Carried. It was moved by Mrs. Cox, seconded by Mrs. Lupton and carried that after the June meeting, when all Chairmen are named, that each Chairman be given \$3.00 for Committee Chairmen Expense for the year, and that all other bills for supplies, etc., be presented to the Board for approval and authorization of payment. The Secretary was asked to secure prices for new stationary and confer with Mrs. Smith. Mrs. Smith's approval is all that will be necessary for the purchase of needed stationary. Discussion followed concerning the Treasurer being permitted to accept contributions at any time during the year. It was moved by Mrs. Gibson, seconded by Mrs. Wood and carried, that the Treasurer be instructed to accept any contributions at any time.

Mrs. Cox reported the resignation of Mrs. Fred G. Leach, Corresponding Secretary, due to the fact that her husband is running for office in the coming election. Mrs. Cox also reported the resignation of Mrs. W. E. Watts, Jr., Constitutional Revision
