LEAGUE OF WOMEN VOTERS

March 31, 1969

The combined meeting of the outgoing and incoming boards was held at the home of Mrs. Merlin Barber, 934 W. William, with Mrs. Janet Westenhaver presiding.

PRESENT: Mesdames Mestenhaver, Barber, Schade Grow, Hippler, Johnson, Protzman, Hann, Meinman, Hiller, Heilman, Beck, Mee, Coberly, Ohlsen, Deffenbaugh and Bowers.

ABSENT: Mesdames Butler, Dakin, Duras and Homan.

HENUTES: The minutes of the regular board meeting, February 20, 1969, were approved as read. The minutes of the March 21 special boardmeeting were approved as read.

TREASURER'S REPORT: Cash on hand, 3-1-69, Oh49.43. Total Receipts, \$549.70. Expenditures, \$527.57. Cash on hand, 3-31-69, \$471.56. As of 3-31-69, the 50th Anniversary Finance Drive total in the Mutual Home and Savings account amnounted to \$1,188.50.

ANDOUNCE Larrs: 1) Hrs. Schade announced that 8 Decatur LNV members attended the briefing at the League office in Springfield during our March 25 visit to the Legislature. 2) Hrs. Schade said we will have 7 delegates attending the LWV State Convention in Peoria April 22, 23, and 24. There is a visitor's pass for those wishing to attend for one day. Inyone wishing to be an alternate delegate should contact ..rs. Schade. 3) ..rs. lestenhaver rend the State summary of school consensus questions, attached to the secretarie's copy of the minutes. 4) Copies of THE PEOPLE'S PRESIDENT, a book that has been hard to obtain, will be on sale at the Convention for 2.00 a copy. It is on the recommended reading list for the Electoral College study. 5) NBC will present a series of TV programs dealing with poverty starting Easter Sunday. The title is Challenge of a Closer Hoon. 6) Mrs. Hiller announced a Tuesday evening TV program presenting former Ambassador Reichauer on Japan. 7) Hrs. Westenhaver read a communication from the Decatur Education Association concerning a speach by a former Mational Education Association president to be held April 11, at 7:30 under DEA sponsorship. 8) The Governor's Conference on Youth will be May 15 & 16 at the Pick-Congress Hotel in Chicago. 9) A communication from Decatur School Superintendent Harmon Baldwin asked for the names of three LWV members as candidates to work on a co-mittee to develop a long range plan for building or replacing school buildings. 10) A communication from the National LWV office states that April 17 is the kickoff for the 50th Anniversary Fund Drive. 11) A statement from State Human Resources Chairman Janet Otwell agreed that we were within League position in supporting the Decatur Fair Housing Ordinances when a Decatur LNV member testified before the Feb. 2h City Council Meeting. The City Corporation Council had questioned the legality of the leasures we were supporting. 12) Mrs. Schade had been asked by Mr. Lindley Murt of the Macon County Meritage Committee to ask our members to write letters to the Macon County Conservation District supporting the purchase of the Ogelsby Mansion. This is not a League position, but the board agreed to consider asking the membership (in the VUTLR) to do this as individuals if they so desire. If the idea is controversial, we may want to present both sides as a voters service. 13) Mrs. Westenhaver announced that at an invitation from the Champaign LMV, several of our State Convention Delegates had aggreed to meet with Champaign delegates to work on a Water and Air Pollution item for presentation at the convention.

FOREIGN POLICY: Mrs. Miller presented the program for the April 1 and 2 units. It wil cover: 1. China Today, 2. Chinese Foreign Policy Goals, 3. U.S. Interest in Asia and 4. Communism vs. Democracy in Asia, 5. The Korean War, 6. Asian Countries, The Government and the People, 7. Chinese Relations with Asian Countries, 8. U.S. Relations with Asian Countries, 9. Outlook for Peaceful Settlement in Vietnam and 10. The Role of the U.S. in Asia.

ELECTORAL COLLEGE: Mrs. Crow presented a study guide for the Electoral College for use as a general cutline for the April 16 meeting. The study guide was accepted by the board. (Copy attached to Secretaric's minutes.)

SCHOOL STUDY: Mrs. Schade said the School Study committee has received more information than can be used by the local news media, and the committee would like to cut some of it before distribution to the media. However, they would like to publish the complete information in the VOTER. The board aggreed to this. Mrs. Bowers moved we authorize the distribution of 10,000 copies of the School Board Candidates and the City Council Candidates Fact Sheets to be distributed through Voters Service. Seconded and passed. Mrs. Hee asked for 150 copies of each fact sheet to be sent to contributors.

HUMAN RESOURCES: Mrs. Beck announced that the Community Housing Survey her committee recently completed is due in the National Office by May 1 to be used in drafting consensus questions for next Fall. She presented questions to be included as part 8 of the survey and roved that the questions be accepted by the board. Seconded and passed.

PUBLIC RELATIONS: Mrs. Barber said she is sending letters to the State and national people we hope to have speaking on the special telephone lines during the Community Conversations program with WDZ.

ORGANIZATION: Mrs. Heilman said information on the April 1 units will be in the Voter.

FINANCE: Mrs. Mee read letters from a couple of our contributors commending our Local League. We have now received \$1,221.50 from our members. The usual member contribution is around \$200.00 Non-members have contributed \$695. She has half the cards in from the solicitors and would like to send a follow-up letter to contributors who have not yet denated.

Mrs. Mestenhaver presented the following letter to be sent to the Mayor with copies to Corporation Council Landholt and members of the City Council concerning our stand on proposals to the Human Relations Commission. The amended letter follows:

"Dear Mayor Rupp:

On February 24, 1969, a statement supporting certain sections of the Human Relations Cormission proposal was read by Mrs. Robert C. Schade as Decatur League Representative. Mr. Landholt indicated that he felt the League was acting irresponsibly to support passage of ordinances which had not been proved constitutional.

We have submitted copies of the League statement along with the proposals of the Human Relations Corrission to the State Board of the League. They concur with the Decatur League in the following:

Determining constitutionality is not the function of the League, but rather the function of the courts.

We feel therefore that the statement made before the Council was well within a local League position and our current National Position on Human Resources."

The above letter was approved by the board. Mrs. Westenhaver will send the letter over her signature.

WATER RESOURCES: Hrs. Proteman read a report from the State League concerning DDT and other Persistent Pesticides. The question posed in the report asks whether their use should be restricted. The decision of the Board was that we were unable to come to a conclusion based on the facts we had at hand.

Hrs. Westenhaver presented to Mrs. Schade, the incoming president, her notebook, a gavel which will be inscribed, and a "rest-a-phone" attachment for her telephone.

The next ceting will be April 30.
