MINUTES OF BOARD OF DIRECTORS MEETING - JULY 21, 1967

THE REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE DECATUR PUBLIC LIBRARY WAS HELD ON JULY 21, 1967 IN THE BOYD ROOM OF THE MAIN LIBRARY.

THE MEETING WAS CALLED TO ORDER AT 4:40 P.M. BY MR. OLSEN.

THE MINUTES OF THE REGULAR BOARD MEETING OF JUNE 16, 1967 WERE APPROVED.

MR. DUMAS REPORTED A 5000 INCREASE IN CIRCULATION FOR THE MONTH OF JUNE AND STATED THAT HE IS GLAD WE ARE REACHING MORE PEOPLE. HE FURTHER REPORTED THAT REQUISITIONS SUBMITTED TO THE CITY SINCE MAY OF 1966 CAME THROUGH THAT DAY, JULY 21, 1967, AND THE BACKLOG OF AGING VOUCHERS HAD BEEN GREATLY DIMINISHED.

MR. DUMAS STATED THAT MRS. MURIEL PERRY TRAVERS HAD COME TO THE LIBRARY TO WORK PART-TIME AS ACTING SUPERVISOR OF TECHNICAL SERVICES. HE ALSO ANNOUNCED THE APPOINTMENT OF A REFERENCE LIBRARIAN, MISS MARGARET MEYER, A RECENT GRADUATE OF THE UNIVERSITY OF ILLINOIS LIBRARY SCHOOL.

IN HIS REPORT ON THE AMERICAN LIBRARY ASSOCIATION CONVENTION IN SAN FRANCISCO, MR. DUMAS STATED THAT THE THEME OF THE CONVENTION WAS MANPOWER SHORT-AGE. HE STATED THAT THERE WERE OVER 500 ADVERTISED VACANCIES AND FEWER THAN 100 ACTUAL CANDIDATES FOR THE POSITIONS. THOSE INTERESTED IN PUBLIC LIBRARY WORK SPECIFIED EITHER EAST COAST OR WEST COAST. MR. DUMAS REPORTED THAT HE "COULD NOT EVEN GET AN INTERVIEW WITH AN APPLICANT AND THAT UNLESS WE CAN GET ADEQUATE PROFESSIONAL STAFF, WE CANNOT ADEQUATELY TRAIN THE SEMI-PROFESSIONAL HELP THAT WE HAVE. WE ARE GOING TO CONTINUE ADVERTISING. IT MAY BE THAT WE WILL HAVE TO RAISE OUR BASE SALARIES."

MR. OLSEN GAVE AN INFORMATIONAL REPORT ON THE SUMMARY OF INCOME AND EX-PENDITURES THROUGH JUNE 30, 1967 AND BILLS APPROVED THROUGH JUNE 19 AND JULY 11, 1967. THE REPORT WAS UNANIMOUSLY APPROVED BY ROLL-CALL VOTE.

AS CHAIRMAN OF THE POLICIES, PUBLIC RELATIONS AND PERSONNEL COMMITTEE, MR. SAPPINGTON MOVED THAT LIBRARY STAFF SALARIES BE RAISED IN AMOUNTS COMPARABLE TO ANY INCREASES IN THE CITY PAYMENT SCHEDULE. THE MOTION WAS APPROVED. MR. SAPPINGTON SUGGESTED THAT A LETTER ALONG WITH A COPY OF THESE MINUTES POINTINGO OUT THIS PARTICULAR MOTION BE FORWARDED TO MR. JACK LOFTUS, FINANCE DIRECTOR OF THE CITY OF DECATUR.



MR. SCHUERMAN, CHAIRMAN OF THE NEW CENTRAL LIBRARY BUILDING COMMITTEE, STATED THAT A MORNING MEETING WITH THE CITY COUNCIL HAD BEEN HELD TWO WEEKS AGO TO DISCUSS AND EXPLAIN TO THEM WHY \$20,000 WAS NEEDED TO PROGRAM FOR THE NEW LIBRARY. THE COUNCIL APPROVED THIS AMOUNT.

AS THE NEWLY ELECTED PRESIDENT OF THE BOARD, MR. OLSEN ANNOUNCED THE FOLLOWING COMMITTEE APPOINTMENTS:

PROPERTY AND FINANCE: MR. MILLER, CHAIRMAN, MR. TEBUSSEK AND MR. FREYFOGLE

POLICIES, PUBLIC RELATIONS, AND PERSONNEL: MR. SAPPINGTON, CHAIRMAN, MR. WEST, MR. SCHUERMAN AND MRS. RUSSELL

NEW CENTRAL LIBRARY BUILDING: MR. SCHUERMAN, CHAIRMAN, MR. MILLER AND MR. SAPPINGTON
