Dear Members,



ANNUAL MEETING MATERIALS

PROPOSED PROGRAM FOR 1981-82

County and Township Governments

Support for elimination of townships in Macon County with their functions transferred to general purpose governments, such as the county or municipalities. Support for Home Rule status for the county with establishment of an elected county executive. (If necessary, we would support appointment of an administrator by the County Board until an executive can be elected.)

Support for elimination of as elected offices those at the county level which do not set policy, such as Auditor, Recorder of Deeds and Coroner.

Decatur's Environmental Quality

Support for improved surface drainage of the City of Decatur, as proposed by the Surface Drainage Task Force and the Citizens Advisory Committee for Improved Storm Drainage in 1975.

Decatur Public Schools

Position resulting from 1976-77 study (needs and goals of District #61 educationally, to include areas of responsibility of the school board and administration). The school district needs to make a continuing effort to determine the desires of the public concerning its schools. The Board of Education should present a "state of the schools" message at the end of each school year, and also describe plans for the next school year. The school district should continue to place a high priority on meeting the needs of individuals. The school district should increase its efforts to implement its goal of communications with the public.

Position resulting from 1977-78 study (of the financial resources and condition of District #61). When it is determined that projected revenues will not be sufficient to maintain and/or improve programs, the Board of Education of Decatur Public Schools should ask the voters to increase one or more of the tax rates making up the "operating tax rate" for state funding. Since there is a time lapse between voting an increase and receiving both local taxes and state funds based on the higher tax rates, referenda should be submitted before a crisis situation exists, that is, before cuts have to be made or a deficit exists in fund balances. An increase in the tax rate would be justified to maintain and/or improve programs if:

Decatur's "operating tax rate" was less than districts of similar size. Decatur's "operating rax rate" was less than needed to get maximum state funds.

City Government

Position resulting from 1977-78 re-study of council-manager form of city government and a study of the Home Rule option in city government. After studying the several possible alternative forms of city government, consensus is that the Council-Manager form of government is the best for the city of Decatur. It provides the professionalism and administrative capabilities not

as likely to be found under other forms. Decatur is in many ways similar to a big business; it needs to be governed in an economic and efficient way. By separating the policy-making body, the elected council, from the administrative body, the appointed manager and staff, Council-Manager government provides balance between leadership and management.

Home Rule power of the city of Decatur, granted by the 1970 Constitution of Illinois, has not been misused. The council has been cautious in use of the Home Rule power, and careful to seek the community's specific needs. The Home Rule power should be retained, in order that the local citizens can find the solutions to their own local problems, and not be dependent on the Illinois legislative action.

Family Violence (1980)

Support for local efforts to provide intervention services for victims of family violence. The League will monitor the implementation of HB 1560 and HB 1734 locally.



## Time for Action

April 17, 1981

TO: Local League and ILO Presidents

Action Chairs, Human Resources Chairs

FROM: Jean Peterson, HR Chair

RE: HB 366 - Illinois Domestic Violence Act

WHAT TO DO: Contact your representatives in the Illinois House in support

of HB 366, the Illinois Domestic Violence Act.

This is a new bill, and its chief sponsors are: Greiman, Telcser, Catania, Alexander and Oblinger. Ninety-five other

representatives have signed on as co-sponsors.

The bill expands the civil and criminal remedies available to victims of domestic violence and provides new tools for protection and prosecution by law enforcement officers and states' attorneys.

The major provisions of the bill are listed below:

LEGAL REMEDIES: CIVIL AND CRIMINAL

Orders of Protection: An abuse victim may seek relief through an Order of Protection, which replaces the current civil injunction. An Order of Protection may be obtained (a) by petition in civil court; (b) in conjunction with an action for marriage dissolution, annulment, legal separation or child custody; or (c) in a criminal action as a condition of pre-trial release or post-trial probation or supervision.

An Order of Protection is fashioned to protect victims from continued abuse by family or household members. Any person may initiate proceedings on behalf of domestic violence victims who are children or elderly parents incapacitated by age or illness.

The court may order any or a combination of the following ten remedies:

\*prohibiting the abuser from threatening or continuing the abuse

\*granting possession of the residence to the victim

\*awarding temporary custody or establishing visitation rights of children

\*prohibiting "child snatching"

\*requiring the abuser to undergo counseling

\*prohibiting destruction of the victim's property

\*requiring temporary support of the victim or the abuser's children

\*requiring compensation for medical and out-of-pocket expenses

\*requiring payment of court costs and attorney's fees

\*other injunctive relief that may be appropriate

Violation of the first two is a Class A misdemeanor, a criminal act which gives the police the right to arrest and thereby provide protection before the abuse is repeated.

Interspousal Tort Immunity. Under current law, spouses cannot sue one another in civil actions, whether the "tort" or civil wrong that was committed, was intentional or a result of negligence. House Bill 366 updates the law to allow a spouse who is the victim of an intentional tort, such as assault and battery (which is both a civil and criminal wrong), to recover from a spouse for medical expenses, loss of earnings, or other out-of-pocket losses for injuries sustained.

<u>Law Enforcement Responsibilities.</u> House Bill 366 provides new tools for immediate, effective assistance and law enforcement, placing police and sheriff personnel in the critical role of protecting victims of domestic violence before the abuse is repeated and escalated.

Illinois police and sheriffs are asked to perform a number of functions:

- \*they may arrest without warrant a person who violates an existing Order of Protection or commits a violent act against a family or household member;
- \*they are to make written police reports of every incident of domestic violence, so that statistical data on the incidence of domestic violence may be compiled;
- \*they are to transport the victim of abuse to the nearest medical facility or place of safety, and are to accompany the victim to her or his residence to remove personal belongings;
- \*they are to offer the victim a written pamphlet summarizing the legal options, procedures and social services available to victims of domestic violence; and
- \*they are to offer information on the right to initiate criminal action, where they choose not to arrest the abuser, and the importance of preserving evidence.


In addition, law enforcement officers cannot be sued for their good faith enforcement of the Illinois Domestic Violence Act.

\*\*\*\*\*\*

The League's position is based on League principles (no person or group should suffer legal, economic or administrative discrimination); the Human Resources position (to promote social justice by securing equal rights for all and combating discrimination and poverty) and the ERA position (to eliminate or amend those laws that have the effect of discriminating on the basis of sex and to strengthen the enforcement of such existing laws).

Major opposition to the bill is expected to come from the "pro-family" conservative faction. This legislation, however, is <u>not</u> anti-family - it should help to promote healthy families.

The bill has been pased by the House Judiciary I Committee and is now on second reading. I urge you to contact all of your representatives and indicate your support for this necessary and long-over-due legislation.



## BULLETIN

DOMESTIC VIOLENCE

The House Judiciary I Committee approved HB 366, sponsored by Representative Alan Greiman (D-Skokie-15th District). HB 366 creates the Illinois Domestic Violence Act which provides comprehensive remedies and provisions for abuse directed at any family or household member by any other family or household member. All Democratic members of the Judiciary I Committee overwhelmingly voted "Yes" to move the bill to the House floor. The only two dissenting votes were Representative Patrick Grossi (R-Glenwood-10th District) voting "No" and Representative Harry Leinenweber (R-Joliet-42nd District) voting "Present."

Readers are encouraged to contact their state legislators and ask for their "Yes" vote on HB 366. Also, urge Governor Thompson to support HB 366 as it moves through the legislative process and to sign it when it reaches his desk!

In reviewing our League's by-laws for our Annual Meeting we find that some editorial changes are necessary. The first three articles must be consistent with the new LWV/US By-Laws (1980).

Article II

PURPOSE AND POLICY

Sec. 1. Purpose. The purpose of the League of Women Voters of Decatur, Illinois, is to promote political responsibility through informed and active participation of citizens in government and to act on selected governmental issues.

Section 2. (Political) Policy. The League shall not support o oppose any political party or any carnicale.

Article III

HEABERSHIP

Sec. 1. Eligibility. Any person who subscribes to the purpose and policy of the League shall be eligible for membership.

Sec. 2. Types of Membership. The membership of the League shall be composed of RE- voting numbers and associate members.

WORDED

- a. Voting members shall be those citizens at least 16 years of age who are enrolled in the League at the local or state level; (1) members who reside outside the area of any local league and join the League at the state level shall be members—at—large and shall pay annual dues to the state league; (2) members who have been enrolled in the League for 50 years or more shall be life members and shall not be required to pay annual dues.
- b. All others who enroll in the League shall be essociate members. Those who reside outside the U.S. may join the League at the natheral level and shall pay dues to the League of Women Voters U.S.

These are the changes which affect our local League. There are other changes in the INV/US By-laws which concern National Council Composition and Powers, Article X. Sec. 2 and Sec. 3. and Article XIV. Financial Support, Sec. 2. However, these do not need to be repeated directly in our League's Bylanc.



#### PROPOSED PROGRAM FOR 1981-82

County and Township Governments

Support for elimination of townships in Macon County with their functions transferred to general purpose governments, such as the county or municipalities. Support for Home Rule status for the county with establishment of an elected county executive. (If necessary, we would support appointment of an administrator by the County Board until an executive can be elected.) Support for elimination of as elected offices those at the county level which do not set policy, such as Auditor, Recorder of Deeds and Coroner.

Decatur's Environmental Quality

Support for improved surface drainage of the City of Decatur, as proposed by the Surface Drainage Task Force and the Citizens Advisory Committee for Improved Storm Drainage in 1975.

Decatur Public Schools

Pesition resulting from 1976-77 study (needs and goals of District #61 educationally, to include areas of responsibility of the school board and administration). The school district needs to make a continuing effort to determine the desires of the public concerning its schools. The Board of Education should present a "state of the schools" message at the end of each school year, and also describe plans for the next school year. The school district should continue to place a high priority on meeting the needs of individuals. The school district should increase its efforts to implement its goal of communications with the public.

Position resulting from 1977-78 study (of the financial resources and condition of District #61). When it is determined that projected revenues will not be sufficient to maintain and/or improve programs, the Board of Education of Decatur Public Schools should ask the voters to increase one or more of the tax rates making up the "operating tax rate" for state funding. Since there is a time lapse between voting an increase and receiving both local taxes and state funds based on the higher tax rates, referenda should be submitted before a crisis situation exists, that is, before cuts have to be made or a deficit exists in fund balances. An increase in the tax rate would be justified to maintain and/or improve programs if:

Decatur's "operating tax rate" was less than districts of similar size. Decatur's "operating rax rate" was less than needed to get maximum state funds.

City Government

Position resulting from 1977-78 re-study of council-manager form of city government and a study of the Home Rule option in city government. After studying the several possible alternative forms of city government, consensus is that the Council-Manager form of government is the best for the city of Decatur. It provides the professionalism and administrative capabilities not

as likely to be found under other forms. Decatur is in many ways similar to a big business; it needs to be governed in an economic and efficient way. By separating the policy-making body, the elected council, from the administrative body, the appointed manager and staff, Council-Manager government provides balance between leadership and management.

Home Rule power of the city of Decatur, granted by the 1970 Constitution of Illinois, has not been misused. The council has been cautious in use of the Home Rule power, and careful to seek the community's specific needs. The Home Rule power should be retained, in order that the local citizens can find the solutions to their own local problems, and not be dependent on the Illinois legislative action.

#### Family Violence (1980)

Support for local efforts to provide intervention services for victims of family violence. The League will monitor the implementation of HB 1560 and HB 1734 locally.

Water (1980)

Study of the quality of water in Decatur.


