Membership renewal process changes

In order to streamline the Homestead's annual membership renewals and ensure a more efficient financial reporting structure, the Board recently voted to institute a new membership renewal system.

Beginning in 2019, all Homestead memberships come due for renewal on March 1. Previously, an individual's annual membership due date was staggered depending on when dues were first paid. Moving forward, all yearly memberships will begin March 1 and end the following Feb. 28.

In January, all *Regular*, *Friend* and *Patron* members will each receive a renewal letter encouraging them to

send in their 2019-20 membership dues by March 1. Those members who paid for memberships after March 1, 2018, will receive a pro-rated credit applied to their dues for the 2019-20 fiscal year. Each member's credit, if applicable, will be listed in the January renewal letters.

"I know this all sounds complicated, but I assure you that we will do the work to ensure that this new system works seamlessly and causes no headaches for our members," says Board President Linda Ostrander.

"Thank you for your patience as we implement this new structure to further improve our membership process." •


In Memoriam
