**Regular Meeting**  
**March 15, 2007**

**I. CALL TO ORDER**

Eugene King, president, called the meeting to order at 4:37 p.m. Members present: Mr. King, Rene Corcoran, Shirley Moore, Linda Rowden, Nicholette Rademacher, and Sally Krigbaum. Absent: Carol Craig, Garry Davis, and Beth Coulter. Staff present: Lee Ann Fisher and Karen Bjorkman.

**II. APPROVAL OF MINUTES**

Mrs. Moore moved that the minutes of the February 15, 2007, meeting be approved as presented. The motion was seconded by Mrs. Krigbaum and unanimously approved.

**III. COMMUNICATION FROM THE PUBLIC**

No one was present from the public.

**IV. CITY LIBRARIAN'S REPORT**

The City Librarian's written report was included in the packet. Ms. Fisher added two items. She explained the Warrensburg Barclay Library position on the annexation of Boiling Spring. Sirsi/Dynex is not going to support Horizon 8.0 and they are developing a new product called "Rome" that is supposed to combine the best of both systems.

**CITY LIBRARIAN'S REPORT**  
**April 12, 2007**  
**DECATUR PUBLIC LIBRARY BOARD OF TRUSTEES**

**CITY LIBRARIAN:** Another busy month has flown by. The Decatur Celebration Carnival did not cause any problems, which could be due to the cold weather and poor turnout. However, I am not sure that would hold true if the weather had been warmer. Mike Queary was very easy to work with and kept us updated, and parking was fairly smooth. There were several nice articles in the paper featuring the library. The Jazz series is getting rave reviews and we are planning our 5<sup>th</sup> annual Volunteer Luncheon for May. Sunday May 20<sup>th</sup> will be our last Sunday open till September; we are planning a big program for that day. In addition to my regular meetings, I met with the Recorded Books salesman, several reporters from the H & R, presented a program on eBay selling for the library, conducted trustee orientation and reference librarian interviews, accepted a \$750 check from noon Rotary and attended the unveiling at Lincoln Square Theatre, the preview party for the Health & Fitness Expo, and had 'Breakfast with Kevin', the new EVP of St. Mary's, plus co-chaired the Healthcare panel for the United Way.

**FOUNDATION:** There was a super article in the Sunday special section highlighting the special project. Karen is applying for grants we haven't already tried. We are still waiting to hear from the NEH. The next meeting is April 30<sup>th</sup> @ 4:30.

**FRIENDS:** The Friends "Second Saturday" sale and the bookshelf downstairs continues to do well. They will once again support the Summer Reading Club and will buy the latest Harry Potter book as a drawing prize. They also agreed to purchase book carts and a desensitizer for Circulation. The next meeting is May 10<sup>th</sup>.

**RPLS/SIRSIDYNIX:** We will host the User's Group meeting on April 18<sup>th</sup> and the RPLS Seminar 2007 on the 20<sup>th</sup>. I will be doing a "Decatur Public Library Insiders Tour" @ 2:30 and already have 13 signed up.

**STAFF:** Lillie Mann has been hired as the half-time page. DeAnne Davis will be retiring on April 13<sup>th</sup>. The city will be placing an advertisement for another half-time page sometime soon, as our list has expired and run out. We still have page vacancies. Interviews for a reference librarian have been conducted and an offer extended, but not accepted at this time. They will let me know after the weekend.

**ADMINISTRATION:** Our total number of checkouts in March was 55,530 items, down -6.5% from March of 2006. The weather in March did not keep the patrons home as we had a gate count of 29,254, up +8% from the month of February, 2007 and down -8.4% from March, 2006. The meeting rooms were rented 35 times, earning \$1,270.00 in fees. Karen is getting familiar with the community and has attended meetings with me and in my place, while I was on vacation. She is working on the Tourism Attraction subcommittee planning a "Community Leader Grand Tour" set for Friday May 11, where community leaders are being invited to take a free bus tour of various non-profit organizations in Decatur, which we are one of. She has also submitted several grants.

**ADULT DIVISION:** Our 10 programs had a total attendance of 400. Maria is planning a "Patriotic Celebration", which we will hold in Central Park, May 20<sup>th</sup>, as our last official program. We will have some programs this summer in connection with our 2 exhibits, but as a rule we do not, because of the summer reading club. The 11 online book clubs were accessed 19,020 and they have 951 members. The Local History room had 72 visitors, 18 from out of town. This department is running short staffed 1 librarian and 2 pages.

**BUILDING DIVISION:** When we had our hot spell Bill switched over to AC, then it turned cold and he had to switch the heat back on. We try not to do this as it is hard on the equipment, but there were a lot of complaints from patrons and staff about the building temperature. Bill painted Karen's office. He also installed 2 new hanging heater motors in the boiler room, only 2/4 worked; now they all do. We have had to order generator parts for bookmobile 549 and Bob & Ron will rebuild it when they get here. The steps on 548 were rebuilt also. Although both vehicles are not that old, it is getting difficult to find replacement parts.

**CHILDREN'S DIVISION:** The big program event for March was 2 appearances by Curious George on March 9, which drew about 450 people of all ages. A big thanks to John Wylder who volunteered to don the costume and WILL for providing it. Baby TALK's Lullaby Concert featuring Michael Luxner conducting the Millikin String Arts Ensemble was held the evening of March 7 for the second year in a row. We offered a total of 20 programs, attended by 785. We spoke to 7 groups with 162 listeners, gave 3 outside programs with 45 in attendance, 9 groups used the children's room this month and 387 signed up to use the computers.

**CIRCULATION DIVISION:** The total number of checkouts during the month of March was 45,892 items, up +19% as compared to the 38,477 items checked out in February 2007, and down -6% when compared to 48,809 items checked out in March 2006. We had 7,970 items were checked out of the DPL by patrons from other libraries and DPL patrons checked out 4,743 items at other libraries. Of the 4,743 items checked out by our patrons at other libraries, 2,561 of those items were checked out on the bookmobiles. 1,981 items were routed into the DPL from other libraries to fill requests and 4,869 items were routed out of the DPL to fill requests at other RPLS libraries. We placed 4,541 requests in March, up +16% from February and up +13% from last March. We resolved 6,693 requests and of these, 3,231 items were picked up here at the DPL. We had 332 new accounts opened in March, up -24% from February and down -17% from March 2006. New library accounts are down -16% overall from 2006 at this time.

**EXTENSION DIVISION:** As mentioned in the Building report, both bookmobile experienced mechanic problems this month and we had some sporadic downtime. Ken Banning suggested the library purchased car adapters that allow the laptops to run off the bookmobile's battery. We had 19 volunteers donate 131 hours this month.

**GATES COMPUTER LAB:** We had 94 people attend one of our 12 computer classes offered.

**SYSTEMS ADMINISTRATION:** CybraryN had a few technical problems this month. CybraryN tech support is working on a fix for us. There were a few problems with the new daylight savings time change, but all have been corrected. There were 828 work orders received this month.

**TECHNICAL DIVISION:** Acquisitions bar-coded 1,048 items sorted 39 bins of mail and invoiced 546 items. We had 177 interlibrary loan requests from our patrons and 688 OCLC request from other libraries not in the RPLS consortium. Cataloging cataloged 1,530 titles of which 79 items were reclassified. 701 items were withdrawn and 47 titles were reinstated. 585. We imported 627 new records into the Horizon database and worked on 2,109 new or added copies. Processing processed 646 periodicals as well as 682 paperbacks. We mended 1,038 items there were 250 biographies reclassified and reprocessed. Transfers from other classifications accounted for an additional 20 items. On March 15 the first games were processed for the AV collection.

## COMPUTER USE AND INTERNET ACCESS POLICY

The Decatur Public Library provides access to a broad range of electronic resources including those available through the Internet. The Library makes this service available as part of its mission to provide access to information to help meet the educational, recreational, and professional needs of every member of the community.

### **Rulings Governing Use of Computer Resources**

Use of the library's computers requires a library card *in good standing (less than \$5 in fines)* from Decatur Public Library or any other library in the Rolling Prairie Library System (RPLS). Visitors from outside RPLS may be granted access to the library's computer resources upon presentation of acceptable identification. Access is limited to adults and minors ages 13-17 with written parental permission. Children 12 and under may access the library's computers only when accompanied at all times by an adult with acceptable identification.

Computer users may not:

- Make any attempt to modify or damage library computer equipment or software. Only software owned and installed by the Decatur Public Library may be used on its computers. Downloading or installing anything from the Internet or other software is not permissible.
- Use the library's computers for any illegal activity, including violation of copyright or other rights of third parties. Users will be responsible for knowledge of all applicable federal, state, and local laws for which they may be held in violation.
- Use library computers to view or disseminate material considered inappropriate for a public environment or likely to cause a disturbance, or sexually explicit or suggestive (obscene/pornographic) images.

### **Violation and Enforcement**

Unacceptable or inappropriate use of the library's computer resources may result in suspension or revocation of library privileges, and expulsion from the library. *Includes, but is not limited to using a library card belonging to someone else, not staying in the time management system, not following the library's computer rules.*

Users will be held financially responsible for any damage to library computer equipment and software.

Using computer access obtained at Decatur Public Library to perpetrate illegal acts will be subject to prosecution by local, state, or federal authorities.

## **Disclaimers**

The Library assumes no responsibility for the quality, accuracy, or currency of any Internet resource. Patrons should recognize that, in addition to valuable and reliable information, the Internet does contain inaccurate, dated, incomplete and controversial material. Users should exercise good judgment and discretion in the use of Internet information sources.

It is the responsibility of the parent or legal guardian to restrict and monitor a minor's access to information on the Internet.

The Library disclaims any liability or responsibility arising from access to or use of information obtained through the Internet. Users are responsible for any commercial transactions made while using the Library's Internet connection.

## **Privacy**

Patrons should have no expectation of privacy, as all Internet workstations are in view of other patrons and staff.

## **Security**

Every effort will be made to maintain a secure environment; however Internet transactions, communications and activities are potentially vulnerable to unauthorized access. Decatur Public Library will not release information on the use of specific Internet resources by members of the public except as required by law or necessary for the proper operation for the Library.

## **Behavior**

It is the policy of the Library to provide an atmosphere conducive to the appropriate use of Library services and facilities. The rules of conduct outlined in the Library Use Guidelines apply to all computer users. Patrons shall not use Library computer resources in a way that disturbs or interferes with other patrons, employees or operations of the Library.

## **Compliance**

The Decatur Public Library staff will develop such rules and procedures as are necessary to insure the fair and reasonable use of Internet resources. The Library reserves the right to terminate an Internet session at any time.

## **Policy Modification**

The Library reserves the right to modify this policy at any time.

### **Computer Usage Rules (Current)**

1. Decatur Library and RPLS card holders are allowed four 30 minute sessions per day with a 5 minute wait time between each session. Library card holders over 18 years of age can use an available Internet computer by simply logging in using their library card # and PIN #. Card holders must have their library card with them or know their card number. Library staff does not look up card numbers for patrons. We do look up PIN numbers for patrons who do not know or remember their PIN #.
2. Decatur Library card holders that are between 13 and 18 years of age are required to stop at the Reference Desk to acquire a Guest Pass to use the Internet computers. This allows the Reference Staff to verify that parental permission for using the Internet has been given. Guest Passes also allow four 30 minute sessions with a 5 minute wait time in between each session.
3. Guest passes are also issued to anyone outside of Rolling Prairie. A photo ID is required to do this.
4. Computers in the lab are restricted to one person per computer.
5. No one under 18 may share a computer other than with their parent or guardian.
6. Cell phone usage is not allowed in the Lab.

### **Computer Usage Rules (Proposed)**

1. Decatur Library and RPLS card holders are allowed two 60 minute sessions per day. Following the first session, there is a ~~4~~ hour waiting period before being able to use the second 60 minute session. *15 MINUTE*
2. Decatur Library and RPLS card holders between the ages of 13 and 18 have access to Internet computers as long as their record shows that they have parental permission to use the Internet. CybraryN will block a youth card without parental permission.
3. Guest passes will be issued to library users outside of RPLS. A valid photo ID is required to obtain a Guest Pass.
4. Computers in the Lab are restricted to one person per computer.
5. No one under 18 may share a computer other than with a parent or guardian.
6. Abuse of card usage will result in all parties involved losing computer privileges for a minimum of 3 months.
7. Cell phone usage is not allowed in the Lab.

# Chapter VI Programming

A library can reach out to its entire community through programming. Programs publicize the library, introduce special groups to library materials and services, and provide information and recreation. Library programs are a particularly effective way of introducing the community to a variety of cultures.

It is well accepted that traditional programming for younger children helps them develop reading habits and encourages them and their parents to use the library and its resources. Programs for young adults identify resources that help them understand some of the intellectual, emotional, and social changes they are experiencing. Programs can reintroduce the newly retired to a library that has grown during the years that they did not have time to use it.

If the library opens its meeting rooms, display cases, and other exhibit areas to nonlibrary-sponsored programs and nonlibrary-sponsored exhibits and displays, policies and procedures must cover the use of these facilities. This policy as well as other library policies should be reviewed by the library's attorney.

## Applicable Core Standards

**Core 1.** The library provides uniformly gracious and friendly service to all users.

**Core 4.** The library is in compliance with all federal laws that affect library operations including but not limited to the *Americans with Disabilities Act* [42 U.S.C. 12101 et seq.], the *Fair Labor Standards Act* [29 U.S.C. 201 et seq.] and the *Bloodborne Pathogens Standard* [29 C.F.R. § 1910.1030]. (See appendix 1.)

**Core 12.** The library has a board-approved mission statement, a long-range plan, a disaster prevention and recovery plan, and policies. Such policies include but are not limited to the following topics: personnel; reference; use of the library's materials, services, and facilities including use of the library for exhibits and meetings; and collection management. Illinois statutory law specifically requires the board to establish and review at least biennially a written policy for the selection of library materials (as part of the library's collection management policy) and the use of library materials and facilities [75 ILL. COMP. STAT. ANN. 5/4-7.2 or 75 ILL. COMP. STAT. ANN. 16.30-60]. All library policies are in compliance with state and federal laws. See appendix 2.2.)

**Core 16.** The library adopts and adheres to the principles set forth in the American Library Association's *Library Bill of Rights* and other ALA intellectual freedom statements and interpretations. (See appendices 2.4-2.6 for ALA *Library Bill of Rights* and other ALA intellectual freedom statements.)

## **Supplemental Standards**

1. Library programs are provided free of charge.
2. Library programs are located in a physically accessible location. Provisions are made, as needed, to enable persons with disabilities to participate in the program. The availability of these provisions is noted with other information about the program.
3. The library considers community demographics, special populations, and the availability of programming from other social, cultural, and recreational organizations in the community when planning and evaluating programs.
