Booklet Tells County, City Governments

Local government often is a confusing thing with all the different departments and taxing units. It's enough to make you wonder how it all works.

The answer probably can be found in a booklet printed by the League of Women Voters of Decatur. The title of the 78-page edition is "This Is Macon County—A Handbook of Local Government."

Charts and maps illustrate the structure of both city and county government, public schools, election precincts and party organizations.

For those wondering where their tax money goes, the league booklet describes in detail the various taxing districts which derive their main source of income from the real estate and property taxes collected in Macon County.

The material was compiled with the cooperation of government officials. It was prepared by league committee members under the chairmanship of Mrs. Neal Doubleday and Mrs. Gerald Redford.

The booklet would be especially useful to new county residents, and any resident would find it a good reference source.

Mrs. Harold Tenney, league president, said "This is Macon County" is a 75-cent investment which the league hopes will help Mr. and Mrs. Average Citizen better understand local government."
