

MINUTES OF BOARD MEETING
LEAGUE OF WOMEN VOTERS, DECATUR, ILLINOIS
November 1, 1956

The meeting was called to order at 1:30 P.M. by Mrs. H.W. Gibson, Pres., presiding. Present were: Mrs. Fairs, Martin, Cohn, Cresswell, Leigh, Smith, Frederickson, Gebhardt, Griffin, Woyna.

The minutes were approved as read. The Treasurer's report showed COH at 10/31/56 as \$1,578.97.

The November units will be on the 14th with the program of "Structure of County Government."

The Finance Drive report was given by Mrs. Leigh. A total of \$789 was received with \$173 from members and \$616 from non-members. Mrs. Gibson said that in looking back and going over the cards she felt it was a mistake to hold the drive in August and a mistake to extend the drive to a full month. For best results it might be wise to consider starting the drive immediately after the September Board meeting. There might be a Kickoff Breakfast with the participants going out to see prospects immediately and reporting results at a luncheon.

The League will spend \$50 for an ad on Revenue in both the Herald & Review on the 5th. The Secretary was asked to acknowledge WIVP's contribution in advertising the Blue Ballot.

Mrs. Cresswell reported for Voters Service that Girl Scouts made posters showing correct voting, which they will place in 29 precincts. The rest will be delivered to Mr. Tangney for placement and it is hoped they will be re-usable next year.

So far no one has accepted chairmanship of the Nominating Committee. Mrs. Nicholson was suggested as a possibility.

The Secretary was instructed to send a letter to Mr. Gordon Davis expressing our thanks for his services as a speaker on the Revenue Amendment. Also a letter to Mrs. Key thanking her for the excellent job she did on clippings of the City Council meetings, from May 1955 to May 1956.

Mrs. Gibson gave a brief analysis of the notes and clippings of the City Council meetings. Mrs. Leigh and Mrs. Woyna were appointed to go over the material also. An analysis will be written and copies sent to Board members for approval before sending to League members.

The meeting adjourned at 3:15 P.M.
