BIOGRAPHICAL INFORMATION

Rolland Clark Snell was born around 1889 in Moweaqua, IL to Frank and Josephine Watson Snell. He married Martha Bradley on September 17, 1913, and moved with her to Decatur. Together they had one son, Dr. Frank B. Snell, who went on to marry Virginia Lee Gregson and produce two children. R.C. Snell attended the Alexander Hamilton Institute through correspondence booklets around 1913. He worked as a traveling auditor for Standard Oil Co.

SCOPE AND CONTENT NOTE

This collection contains information pertaining to the Snell Family. The collection is .5 linear foot, and contains booklets from the Alexander Hamilton Institute, photographs, and cards.
