# **DECATUR PUBLIC LIBRARY BOARD OF TRUSTEES**

**Regular Meeting**

**August 17, 2006**

## **I. CALL TO ORDER**

Eugene King, President, called the meeting to order at 4:30 p.m. Members present: Mr. King, Beth Couter, Rene Corcoran, Shirley Moore, Garry Davis, Nicholette Rademacher and Linda Rowden. Absent: Sally Krigbaum and Carol Craig. Staff present: Lee Ann Fisher and Scott Pointon.

## **II. APPROVAL OF MINUTES**

Mrs. Moore moved that the minutes of the July 20, 2006 meeting be approved as presented. The motion was seconded by Mrs. Couter and was unanimously approved.

## **III. COMMUNICATION FROM THE PUBLIC**

Mr. King received no communications from the public.

## **IV. CITY LIBRARIAN'S REPORT**

The City Librarian's written report was previously mailed. Ms. Fisher reported that she spoke to Kim Bauer on August 15<sup>th</sup> and that he would like to look at the Barnwell photograph appraisal information. She further reported that he has ideas for additional appraisers. Mr. Davis inquired about the circulation statistics reported as DPL checkout to other libraries. Ms. Fisher and Mr. Pointon explained that Dynix/Horizon tracks how many items owned by DPL are checked out at other libraries and how many items owned by other libraries are checked out at DPL.

## **V. REPORTS OF COMMITTEES**

### **Personnel, Policy, and Public Relations Committee:**

Mr. Davis noted that the committee did not meet in August.

### **Finance and Properties Committee:**

Mrs. Couter reported that the committee did not meet in August. She repeated Mrs. Moore's question from the July meeting regarding the nature of the \$1,000 payment made to United Parcel Service. Mr. Pointon replied that he had looked into that expenditure and it was a deposit payment made to UPS to cover incidental shipping costs over the next few months. Mrs. Rowden made a motion to approve the July bills as presented. Mrs. Rademacher seconded and the motion carried unanimously by roll call vote. The YTD Budget statement was reviewed and Ms. Fisher explained that as of August 1<sup>st</sup> the budget year was 25% over and noted that the overall budget was about 31% spent. She explained that this still reflects the aftereffects of the retro-pay disbursement given to the Union staff. Ms. Fisher further reported that a meeting was held in August to start planning strategies for a presentation to City officials to explore increasing the library's budget.

### **Rolling Prairie Library System:**

Mr. Davis reported that there was no RPLS meeting in August.

**Friends of the Library:**

Mr. Pointon reported that the Friends are gearing up for their big annual sale on Labor Day Weekend. He also reported that at their regular August meeting, the Friends Board voted unanimously to accept responsibility for Books Between Bites programming during the summer months of June, July, and August.

**Foundation:**

Ms. Fisher reported that the Foundation met on July 31<sup>st</sup> and discussed marketing strategies for the capital campaign and recruitment possibilities for new Foundation Board members. Mr. Pointon noted that in October he will be submitting the follow-up application for the NEH Challenge Grant.

**VI. SERVING OUR PUBLIC: STANDARDS FOR ILLINOIS PUBLIC LIBRARIES**

*Chapter X: System and ILLINET Membership Responsibilities* was reviewed and Ms. Fisher noted that the library meets or exceeds all requirements of this standard.

**VII. OLD BUSINESS**

At 5:00pm Mrs. Moore made a motion to go into executive session to discuss the sale of library property. Mrs. Rowden seconded and the motion carried unanimously by voice vote.

At 5:15pm Mr. Davis made a motion to come out of executive session. Mrs. Rowden seconded and the motion carried unanimously by voice vote.

**VIII. NEW BUSINESS**

There was no new business to discuss.

**IX. ADJOURNMENT**

Mrs. Couter made a motion to adjourn. Mrs. Rademacher seconded the motion and it carried unanimously. Mr. King adjourned the meeting at 5:25 p.m.

**CITY LIBRARIAN'S REPORT**  
**September 14, 2006**  
**DECATUR PUBLIC LIBRARY BOARD OF TRUSTEES**

**CITY LIBRARIAN:** The Library started its new hours September 1<sup>st</sup> by closing that Friday at 5:30. Our first Sunday to be open was September 10<sup>th</sup>. I asked Brian Looker to explore the possibility of adding video games to our AV collection, which I discussed pros and cons of with several staff members. After that meeting Brian incorporated the recommendations and presented the proposal to the Division Heads and I will submit to next month's policy committee. We had lots of good press coverage this month with several articles featuring programs and future events planned for the library. I weeded through L in the fiction section. Once again space has become an issue and we may have to start shelving on the bottom row again, something we strive not to do. In addition to my regular meetings I started my three-year term on the Illinois Library Association Public Policy Committee. I can attend most monthly Monday meetings by v-tel at RPLS. Scott and I had lunch with the Springfield public library director and her assistant. I attended a reception to welcome the new District 61 superintendent, Gloria Davis, the Communityworks project report session, the Decatur Legacy Annual Do Something Great luncheon. I had several speaking engagements, one to the senior ladies lunch at the Salvation Army and the other to the railroad retirees' breakfast. I also had my annual evaluation.

**FOUNDATION:** On August 15<sup>th</sup> Representative Bob Flider made a check presentation of \$25,000 part of a \$100,000 grant from the Department of Commerce and Economic Development. Scott is working on our reapplication to the NEH. We have a balance of \$152,745 in the foundation accounts. The next meeting is October 23<sup>rd</sup>.

**FRIENDS:** The annual book sale grossed \$15,760. After expenses they expect to net around \$13,000 for project grants.

**PNG:** The PNG Financial Report was submitted to the state by the August 31<sup>st</sup> deadline. All funds, including those rolled over from last year, were expended. Brian, John and Rhalo attended the annual PNG picnic in Springfield on August 8, along with twelve Webster Cantrell students and their supervisors.

**RPLS/SIRSIDYNIX:** I attended the RPLS Advisory Board where director Bev Obert discussed what was happening at the state library and RPLS, now and in the foreseeable future.

**STAFF:** On August 21<sup>st</sup> our new Library Page Patricia Harding began work. There are no other vacancies being filled at this time.

**ADMINISTRATION:** The total number of people visiting the library was down, as is usual at this time of year, but our circulation was way up. The total DPL circulation for August was 50,639 as compared to 49,864 in August of 2005 for a difference of +1.6%. The gate count was 27,828 this month as compared to 29,561 in August 2005 or -5.9%. The YTD total is -1.0%

as compared to last year at this time. The meeting rooms were booked 27 times with \$1,290 in fees collected. Scott attended the second installment of the Synergy program.

**ADULT DIVISION:** The fall program schedule and the September Coming Attractions were completed. Publicity and invitations for the Hamilton exhibit moved into high gear this month. The first Teen Summer Reading contest ended with the final drawing on August 31<sup>st</sup>. The Pirate Reading contest had 53 individuals participating, who submitting a total of 168 entries. Our 865 online book club members accessed it 17,300 times last month. The Local History Room had 107 visitors and 27 were from out of town

**BUILDING DIVISION:** Bill and his crew took 45 pallets of books and AV to the Civic Center for the Friends book sale. In addition to the regular supplies he brings back on Tuesday, he brought back 5 pallets of records that the Friends wanted to keep, which we normally don't do. We installed rubber tile in the entryway to replace worn carpet. It matches the tile we put in last year.

**CHILDREN'S DIVISION:** The summer reading program is over; however kids are still trickling in for their reward books. Alissa has already attended a workshop at RPLS for next summer reading program, *Mission Read..To the Library and Beyond!* Our 15 programs had 256 attendees. We had 5 group visits bringing in 100 people, and 13 groups used the children's story room.

**CIRCULATION DIVISION:** Total number of checkouts during the month of August was 46,558 items, down -10% as compared to 51,640 items checked out in July 2006. There were 7,518 items were checked out of the DPL by patrons from other libraries, 1,348 of those were to DPL extension patrons, 3,324 items were checked-out to DPL patrons at other libraries and 1,251 of those items were checked-out to our patrons on our bookmobiles. We placed 4,255 requests, up +11% from July and up +40% from last August. We resolved 6,166 requests and of these, 2,928 items were picked up here at the DPL. We routed in 2,640 items to fill holds picked up at the DPL and routed out 4,191 items to other libraries to fill requests. We had 349 new accounts opened in August, up +7% from July 2006.

**EXTENSION DIVISION:** The start of the new school year brought many changes with it this year. John finally arranged a bookmobile stop with the principal of John's Hill School; this is significant because Johns Hill is the English as a Second Language school for Decatur. We're hoping that this will slowly work to give us an inroad to the Hispanic community in the area. We also began a new policy in Extension of mailing new library cards along with a letter explaining library policy to students and their parents at our school stops instead of giving them directly to them. This way, parents are clearly aware that their children have cards, and that they are responsible for lost items. Hopefully, this will cause fewer headaches for both us and Circulation. We had 22 volunteers donate 237.5 hours of service this month.

**GATES COMPUTER LAB:** We had 93 students attend one of the 10 classes we offered.

**SYSTEMS ADMINISTRATION:** Computer problems continued this month all over the library. CybraryN continued to experience problems and we have an open work order with

them. The new domain controller was locking up daily due to a conflict between domain controller and the firewall PC. The IsaSecure portion of Panda Antivirus did not want to install correctly on the firewall server, it caused a lot of problems. Matt reinstalled the firewall software several times, the latest on 8/31. This seems to have resolved the domain controller locking up, but he is keeping an eye on this. The firewall PC does have Panda AV on it, just not the part specifically for the ISA software. Our Email notices stopped working on 8/17 due to the fact RPLS put us on their blacklist for sending Spam through their email server. Doris advised that our PC doing the notices need to have its own outside IP address which we did. The four new Nims children's computers are setup and ready for use. There were 1,184 work orders received from the staff for this month.

TECHNICAL DIVISION: In the month of August the Cataloging Department: cataloged 1,478 titles, including 142 items that were donated to the library. Imported 148 new records into our Horizon database. Bar-coded a total of 1,190 items. Withdrew 1,293 items from our collection. Recataloged 213 items delivered for reclassification. Reinstated 65 items back into our collection. Made over 1,057 database changes. We processed 682 periodicals as well as 779 paperbacks (bound and unclassed) this month. There were 1,097 items were mended or reworked by the Processing staff. Also, 206 items were reclassified and reprocessed from the biography and 973 areas as well as 44 items reclassified and/or transferred in other areas.
