Petition kits will be sent to all Leagues in July. The summer <u>Voter</u> will include a story and a petition form for members to use. The drive covers three weeks beginning August 21, after both conventions are over. The final deadline for return of the forms is September 13th.

Action: Handgun Control, Responses to Call for Action. Handgun Control Bill HR 11193

The Decatur LWV does not have a consensus on handgun control. The Board discussed the options available to the Decatur LWV in responding to the Call for Action. The first possibility is to organize an all member meeting in July, at which the state position will be read and the membership will be asked whether they concur or not with the state position. The second possibility is to not respond to this Call for Action. The Board chose to hold an all member meeting.
