DECATUR PUBLIC LIBRARY BOARD OF TRUSTEES
Regular Meeting
March 20, 2008

I. CALL TO ORDER:

Eugene King, president, called the meeting to order at 4:31 p.m. Members present: Mr. King, Rene Corcoran, Shirley Moore, Garry Davis, Sally Krigbaum, and Carol Craig. Absent: Darryl Barbee, Nicholette Rademacher, and Beth Couter. Administrative staff present: Lee Ann Fisher and Karen Bjorkman. Others present: Karen Becker, Friends of the Library president, Mike Deatherage and Nancy Rostek.

II. AGENDA:

Approved as presented.

III. MINUTES:

Motion by Mrs. Krigbaum and seconded by Mr. Corcoran to approve the February 21, 2008 minutes as presented. Motion passed on a voice vote - 6 voting yes.

IV. COMMUNICATIONS FROM THE PUBLIC:

Ms. Fisher had no communications from the public.

Mr. King welcomed the new DPL Friends president, Karen Becker, to the meeting and thanked her for coming. Ms. Becker expressed her appreciation to the board and remarked that the Friends look forward to helping the library with its programs and with the renovations of the space for the Cultural Center.

V. CITY LIBRARIAN'S REPORT:

Ms. Fisher went over her report and added the information that the library exhibit "Painted Books" has been set up and that the opening will take place on March 26, 2008.

VI. REPORTS OF COMMITTEES

Personnel, Policy, and Public Relations Committee:
Committee did not meet in March.

Finance and Properties Committee:
Check Register for February was presented.

Motion by Mr. Davis and seconded by Mr. Corcoran to approve the bills for February, 2008. Motion carried by a voice vote, with all board members voting yes.

Ms. Fisher reported that there had been no action on the budget by the City.

Rolling Prairie Library System:

Mr. Corcoran reported that RPLS met at the Barclay Public Library in March to discuss the RPLS budget for the coming fiscal year. Preliminary budget will be finalized in May and approved in June. Two people at the system have not had a raise in two years. The secretary of state has cut the amount of per capita for the upcoming year. February 19, 2008. There are fifteen scholarships for students working on an MLS being offered by the state.

Friends of the Decatur Public Library:

Mrs. Krigbaum asked Karen Becker to give the report. Ms. Becker was pleased to announce that the Friends will contribute \$20,000.00 more toward the Local History Room renovations. They will release the original \$50,000.00 in June and add \$10,000.00 in June, with the final \$10,000.00 after the September book sale. They had a Second Saturday Book Sale last night with a profit of over \$1,000.00. They have made some budget changes. Requests from the library can be submitted on an ongoing basis over the course of the year. All other requests will need to be made after the September book sale.

Foundation:

Next meeting is Monday, March 24, at 4:00 pm.

VI: OLD BUSINESS:

Ms. Fisher reported that with the pay raise from \$20 to \$25 per hour, all security guards will be staying. The Blue Connection has sent the library \$298 from the sale of the Barnwell print. There are still three libraries interested in the Blue Bird bookmobile at the present time. Ms. Fisher has spoken to three non-profits about the space on the second floor of the Library Annex and none of them have indicated an interest after they hear the price. Mark Gibson is working on the lease with Glenda Williamson Realty. The State overruled the County on the non-profit status for the Library Annex, and there will be no taxes due for 2007.

Ms. Fisher reported that the library more than meets the requirements for this standard.

CITY LIBRARIAN'S REPORT
April 9, 2008
DECATUR PUBLIC LIBRARY BOARD OF TRUSTEES

CITY LIBRARIAN: April is always a busy month as it is the last month of our fiscal year. The opening of the "Farm Life" exhibit was well attended. We have had good publicity with both the newspaper and the TV media covering the exhibit. United Way has been taking up every Tuesday for a while, but will end later this month. I attended PLA in Minneapolis Minnesota March 26-30. I will be on vacation April 22-28.

FOUNDATION: The Foundation met March 24th. They approved a donor letter to be sent out in April, informing previous donors of the change in location of the cultural center. They also approved two fundraising ideas benefiting the capital campaign for further discussion. One was having a "murder in the library" and the other was a musical program with a performer on the level of David "Fathead" Newman. Further information on these ideas will be brought up at the next meeting.

FRIENDS: The Friends approved another \$20,000 for the capital campaign to help the Foundation reach the build-out amount on the cultural center. Their original pledge of \$50,000 plus \$10,000 will be paid in June 2008, with an additional \$10,000 to be donated in September after the annual book sale. The Friends viewed their new space in the Library Annex for the Second Saturday Book Sale. There were some concerns that the space was smaller than their current space.

RPLS: We will host the Governing Board and the Users Group on April 16th.

STAFF: Circulation has two new staff members, Rae Ann Campbell and Mary Jo Schanuel, both part-time clerks. The half-time Circulation Page job still has not been filled. The position opened on January 25th and interviews will be conducted April 14-15 to create a new list. The posting for the Assistant Circulation Supervisor closed on the 27th of March. Interviews will be held in May.

ADMINISTRATION: Karen attended the Community Breakfast on March 18 and the Education Coalition meeting on March 27, 2008. She spoke at the Golden Kiwanis meeting on March 26, 2008. Our meeting rooms were booked 69 times earning \$900.00, but were in use 134 times. The annual volunteer luncheon will be held on May 1st in the Madden Auditorium.

ADULT DIVISION: Dove has added three additional dates for tax assistance; April 8, 10 and 15, in order to accommodate the increased number of filers. We are developing our first summer reading club for adults to run concurrently with the Children's and Young Adult SRP's. Plans for the 2nd annual "A Patriotic Celebration in Central Park" are underway for May. March was a busy month for programs. Our 11 programs had 367 attendees, 2 of the best attended programs were both music. We had 206 people use the online databases this month and patrons logged 151,040 minutes on the internet. Our 11 online book clubs were accessed 21,920 times

by 1,096 members. The selectors ordered 18 carts of materials. Our Local History Room had 66 guests and 18 of them were from out of town.

BUILDING DIVISION: The Farm Life Exhibit came in on the 13th and we had to borrow the fork lift from the Civic Center to unload the crates. There were 14 crates in all. It took staff from all over the library to assist with its set up. The new frequency drive unit for the building return air fans was installed on the 17th although it appears to have some bugs in it. Bodine is working with Toshiba on the problem. Hopefully, we will have the problem fixed soon and can run all the fans. We had to purchase a de-humidifier for Technical Services to keep the books from warping.

CHILDREN'S DIVISION: On March 7 "Super Why" and his cohort "Red" from WILL were here, with lots of kids enjoying them. Then we had Baby TALK and the MU String Ensemble conducted by Michael Luxner for the annual Lullaby Concert in the Madden Auditorium, with another large crowd. We had 426 kids sign up to use the computers; our 28 programs had 738 attendees. There were 6 groups visiting the department with 112 people, 7 groups used the facilities and 2 outreach programs had 205 attendees.

CIRCULATION DIVISION: Total number of checkouts during the month of March was 46,655 items, up +8% as compared to the 43,075 items checked out in February 2008, and up +1% as compared to 45,892 items checked out in March 2007. The total gate count for the month of March is 28,178. There were 6,414 items were checked out of the DPL by patrons from other libraries and DPL patrons checked out 3,958 items at other libraries. Of the 3,958 items checked out by our patrons at other libraries, 2,015 of those items were checked out on the bookmobiles. There were 1,852 items routed into the DPL from other libraries to fill requests for pick-up at the DPL and 5,404 items were routed out of the DPL to fill requests at other RPLS libraries. That makes the combined circulation total 52,059. We placed 5,224 requests in March, down -1% from February and up +15% from last March. We resolved 7,567 requests and of these, 3,546 items were picked up here at the DPL during the month of March. Overall, request volume is up +20% from last year at this time. We opened 319 new accounts in March, up +12% from February, and down -4% from March 2007.

EXTENSION DIVISION: ISAT testing began the first week of March and Easter fell at the end of the month—this is reflected in lower than normal circulation numbers since for two weeks students were testing and not visiting the bookmobile, and for nearly a week there was no school at all. On March 28th, John attended a meeting of the Early Childhood Education Consortium. This month we had 21 volunteers donate 132.8 hours this month.

GATES COMPUTER LAB: Our 16 computer classes had 105 attendees, 84 of them Decatur residents.

SYSTEMS ADMINISTRATION: Matt finally got the Cisco firewall up and running on the 23rd. Most of his time this month was dealing with problems as they arose. We did lose the ability to block by URL and domain name. We are working towards getting the internet traffic split onto the 2 T1's, with patrons on one and staff on the other to increase our speed, before all internet use was on 1 T1. CybraryN is working on the issue of patrons not getting their second

session when signing up for a computer using the Q PC. They state they will release the fix on April 14th, 2008.

TECHNICAL DIVISION: Acquisitions processed 292, barcoded a total of 891 items, processed 191 newspapers, 429 periodicals, 67 reference periodicals, and deleted 23 periodicals. The department received and sorted 35 bins of mail; received 212 packages, of these 86 went to other areas of the library, sorted and prepared for delivery 270 bins of material from RPLS. Our patrons requested 142 items on ILL and of this number 14 were filled in Illinois and the rest were requested from out of state. Incoming OCLC requests to us numbered 760; 153 from other libraries in Illinois and 124 from out of state were filled by DPL for a total of 277 filled and 483 unfilled. Cataloging started a new reclassification of the 600s. This is a task that may take us well into fall of next year. We cataloged 1,139 titles including 80 donated items. A total of 249 items were reclassified, we reinstated approximately 14 titles into our collection. We made 22 agency changes, made approximately 1,321 database and 196 marc record changes, imported 292 new records into the Horizon database, did item work on 1,528 local new or added copies, and withdrew 901 titles. Processing handled 1,898 items, mending Books & Periodicals 348, Audiovisual 178, and Jacket Replacement 149. Reclassifications and Transfers: 39 biographies and 973, Fiction to 800 – 5, Auto books 8, Extension to Main – 48, All others 65.
