

MINUTES OF BOARD MEETING
LEAGUE OF WOMEN VOTERS, DECATUR, ILLINOIS
OCTOBER 4, 1956

The meeting was called to order at 1:30 P.M. by Mrs. Virginia Gibson, Pres., presiding. Present were: Mrs. Griffin, Unger, Cohn, Frederickson, Gebhardt, Smith, and Woyna.

The treasurer's report for the 6 month period was accepted as read. She felt we were in pretty good condition with CCH at 10/1/56 of \$1,594.43.

The resignations of Mrs. Hurley and Mrs. Adelman were accepted with regret by the Board. Mrs. Eileen Gebhardt will become 1st V.P. in charge of Public Relations. Elizabeth Foster will join in November as Judicial Chairman.

The finance report showed \$731.00 received with \$575 from non-members and \$156 from members. Mrs. Cohn moved the Finance Drive be closed. Mrs. Frederickson seconded the motion; motion carried. Thank you letters will be sent to all donors. The new membership list will be out this month and Pauline Martin will start on personnel cards.

The 6 speakers for the Revenue Amendment have given about 6 speeches with around 17 more slated. There is material to be distributed - about 2500 pieces downtown Mon., Nov. 5, and if possible 25,000 copies to school children. It was suggested there might be an ad placed in Sunday's paper on Nov. 4. Mrs. Cohn moved we participate in publicizing an ad on Nov. 4 together with other interested agencies at a minimum cost. Motion carried.

The October units will be on the 17th. It has been decided to try having the night meeting at a home with the hostess asked to call those who might be specially interested.

Mrs. Hurst has been appointed to telephone for members to attend the meetings of the City Council, School Board, and Board of Supervisors.

We now have all the clippings on City Council meetings so will have an analysis of the data at next meeting.

Mrs. Bolton, Miss Bridges, and Mrs. Doubleday will be asked to serve on the By-Laws committee.

A new Voters Handbook is out and we will send copies to Mr. Grant and Mr. Woodward. Mrs. Cohn moved we purchase 20 copies, seconded by Mrs. Unger, carried.

Mrs. Birt will be asked to attend meeting of Citizens Traffic Safety Council. Mrs. Wiza will be asked to attend Assn. of Commerce dinner re Education.

There being no further business, meeting adjourned at 3:00 P.M.
