

The Board of Directors of the League of Women Voters of Decatur, Ill. met Thurs. Dec 3 at 1:30 p.m. in the Association of Commerce Conference Room with 13 members present. The meeting was opened by Mrs. John Slauan. The minutes of the Nov. meeting were read and approved and it was announced that we had a total of \$1655.³⁸ in the treasury.

for "Voter Handbooks" - Mrs. Kuhns made a motion that we buy 100 new Handbooks to be given out to schools - Mrs. Gibson seconded. Motion carried.

Mrs. Smith made a motion that we invite Mrs. Foreman for a luncheon meeting on Tues - Jan 26. Mrs. Lupton seconded - Motion carried.

Mrs. Hanovan announced that State Board Members would attend our Feb. board meeting.

Mrs. ^{and} Schudel reported on findings of expenses to Chicago and recommendations. Mrs. Cox made a motion that the president be authorized to offer ^{upto} \$15 with any additional expenses to be considered by the board. Mrs. Smith seconded - ^{Motion} Carried.

Mrs. Smith read a letter to be sent to National and State on the Pricker amendment expressing a predominance of opposition.
