

MINUTES OF BOARD MEETING
SEPTEMBER 18, 1990

The meeting was called to order at 7:15 PM by the president, Anita Dupree. The minutes of the previous meeting were approved as mailed. The Treasurer's Report was omitted. Barbara Brown reported that the auditors report has been received from Dave Marshall with some suggestions which will be implemented. For example, you must have a receipt and sign a voucher to receive compensation .

ANNOUNCEMENTS: Agnita announced that insurance is available to us for bodily injury or damage which might occur at any of our meetings. It will cost \$50.00 for less than 50 members.

Laura Verbanac moved that we pay the \$50.00 premium for liability insurance through the State LWV. Siobhan DiZio seconded. The motion carried.

The State League advises that we vote "YES" on the Constitutional Amendment on the November ballot. It will speed up return of tax delinquent property to the tax rolls. This amendment does not apply to single family residences or apartments of six or less.

There will be a J.C.Penny Tele-Conference on October 13, at Champaign. It was decided not to take part.

PROGRAM:

Milli announced that Dr. Robert McIntyre, of Milliken University, will speak on the Middle East at our October dinner meeting at Aloha.

← At the November membership meeting, Ron Shaeffer, from Mc Arthur High School, will speak to us on the environment.

Milli announced that the Women of Excellence Award Dinner will be held on April 4, and suggested we nominate Agnita Dupree. No category was decided upon.

Board members felt our September membership meeting was informative and somewhat alarming since it was reported all of the aid agencies in Decatur are running out of funds and no more State or Federal money is forthcoming despite growing numbers of needy.

Ideas and names of possible new members were discussed. It was decided to send a copy of the Voter to Mary Jo Novak.

VOTERS SERVICE:

Agnita read a letter received by Kathy Owen from the Co-operative Extension Service of the U. of I. requesting League support of \$50.00 for a Child Care Resource Service Special. Andrea moved that we do not fund. Barbara Brown seconded and the motion carried.

The Board voted to change the date of the October Board meeting. The October meeting will be on Monday, October 15, at the home of Barbara Brown.
