MINUTES OF THE SECOND HALF OF THE ANEUAL MEETING LEAGUE OF WOMEN VOTERS OF DECATUR, ILLINOIS May 12, 1955

The meeting was held at 9:30 at the home of Mrs. Ely Balgley with the President, Mrs. Hurst, presiding.

Mrs. Hurst announced that this was the second half of the annual meeting. It was recessed from March 9th to permit adoption of Local Program for 1965-66 after all local resource committees had reported and to permit Treasurer's report to be made after the end of the fiscal year, March 31st. Before annual meeting business was taken up our delegates to the state convention, Lola Smith, Irene Colvis, Shirley Landholt, and Elise Hurst reported on the convention which was held in Springfield April 29-30. Myra Becker and Pauline Jurgens also were delegates to the convention but were unable to attend this meeting.

Treasurer's Report: Mrs. Mann reported that the year began April 1, 1964 with a balance of \$990.86. During the year receipts amounted to \$2206.98 making a total of \$3197.84 to be accounted for. Asbursements amounted to \$2833.24 including \$500.00 put into an "Unallocated Reserve Fund". Actual expenditures were \$2333.24. Balance in checking account at the end of the year March 31, 1965 was \$364.60. In Reserve Funds there is \$1636.66 (for revision of "This is Macon County" \$1136.66 and in the "Unallocated Reserve Fund" \$500.00). The expenses for action on Council Manager Retention and School Bond Referendum will come from the "Unallocated Reserve Fund".

The finance drive was most successful under the co-chairmanship of Marilyn Miller and Bonnie Livergood realizing \$1420.00 which was \$220.00 over the budgeted goal. Therefore rather than having to take \$350.00 out of capital reserve as budgeted only \$126.26 was needed. An unusual amount of Voters Service activity this year made expenses in this area considerably higher than in past years; there were two Candidates Meetings and a large distribution of voting information.

By-Law Amendment: Mrs. Hurst presented the following By-Law Amendment suggested by the board res Article VI, Sec. 2. Dues: "Annual dues of five dollars (\$5.00) shall be payable on the first day of the month in which a member originally joined. Any member who fails to pay dues within two months after they have become payable forfeits membership". Lola Smith moved that the membership approve this change. The motion was seconded and carried.

Adoption of Local Program: Barbara Redford made individual motions that the following four recommended current agenda items and the four recommended continuing responsibilties be adopted and each was seconded after being presented:

Current Agenda

- 1. Macon County Nursing Home-Study of the need for a County nursing
- 2. Decatur Public Library
 - a. Support for a new main library building.
 - b. Continued study of the operation and needs of the library.
- 3. Decatur Schools
 - a. Support of measures to provide adequate space and educational programs.
 - b. Study of ways to improve public education in Decatur.

4. Urban Renewal

a. Support of urban renewal neighborhood rehabilitation and spot clearance.

b. Study to establish criteria for determining need for

total clearance.

Continuing Responsibilties

1. Support of a sewer system which will provide all citizens of the Decatur area with adequate sanitary facilities.

2. Support of sound development of Decatur's water resources.
3. Support of efficient development and operation of the Macon County Health Department.

4. Support of council-manager form of government for the City of

Decatur.

Irene Colvis moved that we amend the County Health Department items to read: Support of efficient development and operation of the Macon County Health Department. The motion was seconded and carried.

In the discussion it was suggested that we could wait until another year on the study for a county nursing home because of the heavy state load for next year. It was noted that there could possibly be twelve study items. Attention was called to the fact that local items should be supported first rather than state Items because the League gains its greatest strength locally. It was pointed out that the Library, School, and Urban Renewal items would be continuing studies and would therefore not require as much work as in the past and that the County Nursing Home study should not be too complicated. The only completely new state item was Housin; and it was suggested that it might be undertaken by the Human Resources Committee since members of that committee have a background for it. Consensus on Human Resources would probably have to be determined in October or November. At state convention it was mentioned that state and national programs which are for two years should be considered over a two year period. Each item is given different treatment and all are not studied intensely each year. Last year we covered national items of Water Resources and Foreign Economic Policy. United Nations should probably be given special attention this October. There is likely to be a national emergency item on Apportionment.

The voting on each item of the recommended current agenda and the continuing responsibilities as amended was taken separately. All items carried.

The meeting adjourned at 11:30.
