MINUTES OF REGULAR BOARD MEETING OF THE LEAGUE OF WOMEN VOTERS, FEBRUARY 3, 1955.

The meeting was called to order by the President at 1:30 in the Chamber of Commerce Meeting Room.

The minutes of the last meeting were read and approved as corrected.

In the absence of the Treasurer, the Secretary read the report which showed a cash balance on hand of 31,541.74. It was noted that we anticipate somewhere in the neighborhood of \$250.00 more in expenses by the end of March. The budget was read and approved.

Elizabeth Lupton, Local Agenda Chairman, read the report of her committee. She said that the committee felt that 2 items were enough, inasmuch as both items were large, namely:

Item 1: A study of local welfare, with action where indicated.

Item 2: Analysis, with action where needed, of governmental units within the County.

General discussion followed concerning the welfare item. Other suggestions by the connittee were: "Know Your Town," "Public Housing, ""Recreation, "Local Election Code." Mrs. Smith.commented that if the question of voting machines came up, the latter suggestion might prove important.

The President asked for a motion for both the budget and the local agenda. Elizabeth Lupton moved that the proposed local agenda which she had just read be accepted. Seconded by Dorothy Morris; motion carried. Mrs. Pauline Winn moved that the Budget be accepted as read; seconded by Rachel Hurley; motion carried.

The report of the Nominating Committee was read by Elizabeth Lupton; committee: Elizabeth Lupton, Betty Simmons, Lola Smith, Florence Wood, Anne Pettee, Chairman. The report follows:

The coming Candidates Meeting was discussed by Mrs. Winn. Questions to be put to the candidates were discussed, also letters and publicity.

Mrs. Nicholson discussed the work of the Individual Liberties Committee. Mrs. Nicholson stated that the committee would simply serve to get interest started in connection with the Freedom Agenda Project, and that letters were to be sent to all meaning organizations in Decatur soliciting their interest and cooperation.

The Trade Survey was discussed, and it was decided to send 3 people to the 2 day meeting in St. Louis, with expenses paid by the League. Motion by Mrs. Gebhardt; seconded by Mrs. Schudel; carried. Mrs. Nicholson, Mrs. McKay and Mrs. Gibson to be the three to attend.

Mrs. Gibson discussed the proposal of the Chamber of Commerce about the sewers. The Sewer Jonnittee is headed by Merril Lindsay. It was noted that the League has a continuing responsibility concerning the sewer program.

There being no further business, the meeting was adjourned by the President.
