Minutes of General Meeting  
League of Women Voters of Macon County  
Held November 12, 1946, 7:30 P.M. (Tuesday)  
In the Millikin Library Building

Mrs Paul Temple presided in the absence of Miss. Redmon  
A general business report was made to the open meeting  
with additional reports being made by Mrs. Robt. Wood's  
committees which were visiting various city governmental  
meetings. Mrs. Clifford Smith also reported on the work  
of the Civic Improvement Committee of the Ass'n of  
Commerce.

Mrs. Temple then introduced Dr. Daniel James Gage, Prof.  
of History at Millikin University, who spoke on the  
United Nations Organization. In his talk he clarified  
several points of difference between the United Nations  
and the Old League of Nations. He pointed to the loose-  
ness in the way the U. N. is set up to function but he  
emphasized that this could possibly allow it to function  
where the old League could not be made to work. He  
regretted that the career men of the League of Nations  
were not being used in the new organization, feeling  
that their international outlook, and experience could  
be invaluable in the new organization.

Many questions were asked by the sixty members and  
guests, at the close of his talk, and much interest  
in the new U. N. organization was felt by all present.
