

BOARD MEETING  
May 3rd, 1951

ixx The Macon County League of Women Voters' Board of Directors held May Board Meeting on May 3rd, 1951, at the Association of Commerce Conference Room, with nine members present.

The meeting was called to order by Mrs. Birt, the President, and the minutes of the previous meeting were read and approved. In the absence of the Treasurer, Mrs. Reid read the report of the Treasurer, which showed a balance on hand of \$375.31.

Mrs. Birt read excerpts from the recent President's letter. The discussion was then opened with reference to the League's invitation to join the Decatur Civic Exchange and to renew our annual membership to the Woman's Council. Mrs. Birt read from the Local *Leaders* Hand Book regarding the cooperation of the League with other groups, and it was decided that inasmuch as the League is prohibited by its By-Laws from participating in the activities of organizations such as these, that the League would not join. A motion was made to this effect by Mrs. Ruedi, seconded by Mrs. Cox, and carried. The secretary was requested to write a letter to each of these organizations explaining the position of the League.

The League has been asked to co-sponsor a public meeting at the Decatur High School, for the purpose of explaining the School Referendum.

The discussion groups will meet at Mrs. Chumbley's home at 1461 West Sunset, and Mrs. Robert Woodl and Mrs. H. J. Pettee will have the program. This meeting will be at (9:30 A.M. and 2:00 P.M. on May 10th. There will be a meeting on the 23rd at the Library at 7:30 P.M. for the purpose of hearing Convention Reports.

It was decided that Mrs. Doubleday will continue with the bulletins but that she shall have an assistant.

A. Wallins; Publication Chairman - Mrs. Otis Chumbley; Membership Chairman - *Mrs. William Hipsher.*

There being no further business, the meeting adjourned at 3:50 P.M.
