





ore than 25 years ago, fall 1979 to be exact, Susie Siefferman moved into the caretaker's apartment at the Millikin Homestead. The Homestead Family Gazette announced this is an article:

The members of the board of James Millikin Homestead, Inc. are delighted to present the new caretaker

for the Homestead, Susan Siefferman. Miss Siefferman is a 1959 graduate of Millikin University where she majored in broadcasting. A native of Chicago, Miss Siefferman visited Decatur relatives often as a child, and says that she decided then that she wanted to settle in Decatur.

Settle in Decatur she did! After graduation from Millikin, Susie's professional life started with 11 years at WSOY, then 21 years with the Spin Shop, a record specialty store in downtown Decatur, 5 years with Illinois Power, and concluded with 3 years at the Millikin University Bookstore. For 49 years she was a dedicated member of the First Lutheran Church in Decatur.



This spring Susie died of cancer after battling it for nearly a year. She was a unique person; so witty, positive and very committed to her faith, so very modest and appreciative. She greatly enjoyed living at the Homestead, not afraid to be alone in this rather large, old structure. She identified with the house and proudly toured people through it.

We are forever grateful to Susie and will miss her friendly personality. The Millikin Homestead not only lost an excellent caretaker, but a friend of preservation. Decatur lost one of its most loyal supporters who in an understated way left her uniquely positive imprint on the Decatur community.

We could not offer this wonderful fundraiser without the support of the Homestead Board and many friends who contributed to this successful event.


