# DECATUR PUBLIC LIBRARY BOARD OF TRUSTEES

## Regular Meeting

October 18, 2007

### I CALL TO ORDER

Eugene King, president, called the meeting to order at 4:33 p.m. Members present: Mr. King, Darryl Barbee, Rene Corcoran, Beth Couter, Carol Craig, Garry Davis, Sally Krigbaum, and Shirley Moore. Absent: Karen Bjorkman and Nikki Rademacher. Staff present: Lee Ann Fisher and Sheila Robinson. Others present: Mike Deatherage, Kathy Collett, Lee Wiley and Nancy Rostek.

### II APPROVAL OF MINUTES

Mrs. Moore moved that the minutes of the September 20, 2007, meeting be approved as presented. The motion was seconded by Ms. Craig and was unanimously carried by roll call vote.

### III COMMUNICATION FROM THE PUBLIC

There was no communication from the public.

### IV. CITY LIBRARIAN'S REPORT

Ms. Fisher reported that a new Gilder Lehrman exhibit is going up in the gallery through November 17 called *Free at Last: A History of the Abolition of Slavery in America*. The October 16<sup>th</sup> program titled *An Evening with a Ghost Hunter* drew 91 people to the auditorium. For the third year, *Project Next Generation* recently began its fall sessions.

### V. REPORTS OF COMMITTEES

#### **Personnel, Policy, and Public Relations Committee:**

Mr. Davis moved to go into closed executive session at 4:36 pm regarding arbitration of the Library Board of Trustees' right to make and define job descriptions. The motion was seconded by Mrs. Moore and unanimously carried by roll call vote. Mr. Davis moved to return to regular session at 4:47 pm, Mrs. Couter seconded the motion and it unanimously carried by roll call vote.

#### **Finance and Properties Committee:**

Mrs. Couter moved to approve the September, 2007, check register as presented. Mrs. Krigbaum seconded the motion and it was carried unanimously by roll call vote.

Mrs. Couter presented the Year-to-Date budget report for information.

#### **Rolling Prairie Library System:**

Mr. Corcoran reported on the meeting of October 16, 2007. An audit had recently been performed and revealed that RPLS' books are in good financial order at this time. Mr. Corcoran mentioned that the next RPLS board meeting will be after this Board's monthly meeting.

**Friends of the Decatur Public Library:** There was no report. It was mentioned, however, that the Friends made \$941 at the October 2<sup>nd</sup> Saturday Used Book Sale. Their membership is now at 328 (both single and family memberships).

**Foundation:**

Next meeting of the Foundation is October 22, 2007. New officers will be announced at that time.

**VI: OLD BUSINESS**

**Lease property:**

Ms. Craig presented a Barnwell Print (Abraham Lincoln) sales/profit projections spreadsheet and proposed advertising budget, which includes framing, printing and advertising costs. Prof. Ed Walker, head of the Art Department at Millikin University, and their "Blue Connection" will oversee the print processing and advertising, and will commence with the operation on December 1. The consensus of the board was to go ahead with this project. Approval to enter into an agreement based on a 75/25% profit split will be presented at the November board meeting.

There was no other new business.

**CITY LIBRARIAN'S REPORT**  
**November 8 2007**  
**DECATUR PUBLIC LIBRARY BOARD OF TRUSTEES**

**CITY LIBRARIAN:** It was a busy month. I even worked the Information Desk for a few hours one day so that we could get all of the reference staff to ILA. Paul Rigsbey one of our long time security officers, retired. It has been harder and harder to find willing officers from the Decatur Police Department. On my suggestion Paul contacted the Macon County Sheriff's Department and now our evening security will be a mix of both agencies. In addition to my regular meetings, I attended the IL Main Street presentation by the Lieutenant Governor at the Arts Council, Gloria Davis "State of the Schools" address at Hope Academy, the "Celebration of Success" at Johns Hill, St. Mary's Hospital focus group at the Decatur Club, and the Board presentation at the City Council meeting. Once again a lot of administrative staff time was taken up with Village Mall, working with Mark Gibson and various board members concerning old and new issues affecting the Village Mall and the Library.

**FOUNDATION:** Sherri Arnold has been elected President of the Foundation, replacing Dick Lockmiller. Karen has applied for a preservation grant from N.E.H. in the amount of \$600,000.00 to help finance the preservation materials and HVAC needed for the Cultural Center. They are waiting for direction from the Board before they continue the capital campaign. Their next meeting is January 22, 2008 at 4:00pm. Please note this is not their regular day or time, they wanted to try something new to see if this would help attendance.

**FRIENDS:** Current membership count is at 329. The total amount collected for new and renewed memberships is \$9,337. The Friends have a balance of \$109,215.24 in their accounts. The next meeting is November 8<sup>th</sup>.

**PNG:** We received an \$11,500 check from the state for PNG. The fall session has already started.

**RPLS/SIRSIDYNIX:** I attend the RPLS advisory board meeting and was invited for the first time to attend the Medium Pubs Meeting by Amanda Standerfer of the Helen Matthes Library. Matt is gone to CODI in Pittsburgh this week. CODI is the user's group meeting of SirsiDynix, our online automation system

**STAFF:** Karen Williams started as the new page on October 29, 2007. The notices have been posted to fill the part time circulation position vacated by Shirley Lee. Nancy Law is back from her medical leave.

**ADMINISTRATION:** We have submitted the annual report to the State Library for the per-capita grant this is usually a little over \$100,000.00. The amount can vary depending on the state budget. Our total number of checkouts in October was 49,483, up +4% from October of 2006. There were 27,464 people in the building during the month of October, an increase of +11% from September, 2007, and an increase of +3.5% from October, 2006. Professional assists for October were 6,189, up by +4% from the previous month and up by +22% from October 2006. The meeting rooms were books 24 times earning \$1,060 in fees.

**ADULT DIVISION:** We have started participating in AskAway (providing virtual reference service). Amy and Brian are each covering an hour a week. The Millikin Faculty Concert dates are finalized. We will host 3 concerts during March and April, two on Sunday afternoons and one in the evening. We have also started looking ahead to possible programs to celebrate Lincoln's Bicentennial. Our 6 programs had 392 attendees. We had 302 people use the online databases and patrons used the internet 173,465 minutes this month. Our 11 online book clubs were accessed 20,980 times by 1,049 members. The selectors ordered 38 carts of materials. Our Local History room had 84 guest and 15 of them were from out of town.

**BUILDING DIVISION:** With the time change and darkness coming earlier, we inspected all the lights in the parking lot and on both buildings. We replaced lights and repaired those that were ours. We do have 1 pole on the south side that does not have a power feed to it and has not been repaired at this time. We also reported to the city those street lights along Prairie and Main that overlook our parking lot and are out. Bill has put the snowplow on the truck, taken the chiller offline and drained the tower on the roof in preparation for winter weather.

**CHILDREN'S DIVISION:** DPS 61 applied for and received a LINCC grant for kids to use i-pods to listen to recorded books, follow along with the text, and discuss in groups. We are a partnering agency, along with Homework Hangout, Project Success, and a couple of other agencies. Our Monarch story times and Caudill book discussion groups continue to be well attended. We had 351 kids sign up to use the computers; our 23 programs had 397 attendees. There were 4 groups visiting the department with 40 people, and 8 groups used the facilities.

**CIRCULATION DIVISION:** The total number of checkouts during the month of October was 44,347 items, up +2% as compared to the 42,324 items checked out in September 2007, and up +3% as compared to 42,053 items checked out in October 2006. The total gate count for the month of October is 27,464. There were 7,306 items checked out of the DPL by patrons from other libraries and DPL patrons checked out 4,561 items at other libraries. Of the 4,561 items checked out by our patrons at other libraries, 2,241 of those items were checked out on the bookmobiles. 2,610 items were routed into the DPL from other libraries to fill requests and 5,136 items were routed out of the DPL to fill requests at other RPLS libraries. When all the items routed out of the DPL to fill requests at surrounding libraries is added to the total checkouts for the month of October, the combined circulation total is 49,483. We placed 5,233 requests in October, up +7% from September and up +23% from last October. We resolved 7,729 requests and of these, 3,542 items were picked up here. There were 314 new accounts opened in October, up +3% from September 2007, and down -4% from October 2006.

**EXTENSION DIVISION:** John attending the annual Association of Bookmobile and Outreach Services convention in St. Louis. For the second year in a row, he was made chair of the website committee. Bookmobile 548 had some problems and we had to take the Colorado, the spare bookmobile, out in its place. 548 is back on the road and everything seems to be working smoothly this week. We had 21 volunteers donate 182 hours this month.

**GATES COMPUTER LAB:** Our 9 computer classes had 96 attendees, 83 of them Decatur residents.

SYSTEMS ADMINISTRATION: Matt met with Doug Coomer to discuss the new phone system. The circuits should be installed around 11/16 and tested. The actual phone equipment is on order. In regards to the additional T1, Richard Mann at ICN is talking with Terri Lipscomb and RCC about installation. He also attended the annual ICN regional meeting in Champaign. ICN is increasing bandwidth on their backbone network. ATT is rolling out Metropolitan Ethernet in Illinois. This means once the hardware part is installed, instead of having to purchase additional T1's a single Ethernet connection will deliver many megabytes of bandwidth based on amount of bandwidth purchased. Not sure when this will become available in Decatur. We had 1,556 patrons logged on to CybraryN computers a total of 5,063 times and used a total of 2,891 hours out of a total 7,176 available hours. There were 809 work orders received from staff.

TECHNICAL DIVISION: Thanks to Maki Ostrander for volunteering her time to assist in translation of the Japanese books donated by members of the Japanese Sister City in order to catalog them. We processed 657 invoices. We barcoded a total of 2,229 items and processed 323 newspapers, 633 periodicals, 102 reference periodicals, and deleted 46 periodicals. We received and sorted 41 bins of mail and 206 packages of these 55 went to other areas of the library. We sorted and prepared for delivery 273 bins of material from RPLS. There were 158 requests from Decatur patrons for material that the library was unable to locate on the RPLS data base, average of 6 to 8 requests per day. We cataloged 1,390 titles for the month of October, unclassified 72 items, withdrew 679 titles, reinstated approximately 27 titles into our collection, replaced bar-codes on 21 items, and made approximately 1,027 database changes. We processed 2,596 items, including 448 paperbacks. Mending accounted for 508 books and periodicals, AV 421, and jacket replacement 249.

## Agreement to Reproduction the Barnwell Photograph

The following is an agreement between the Decatur Public Library (DPL) and Millikin University's Retail Art Gallery, the Blue Connection (BC). This agreement defines the terms by which the DPL agrees to allow the BC to reproduce, for the purpose of distribution, the DPL's Lincoln Barnwell photograph. The BC shall maintain sole distributorship of the photograph for the term of one year upon signing this agreement.

DPL will provide BC access to the Barnwell photograph and negative within 5 days of signing of this document for the purposes of preliminary examination to determine the best method to proceed with reproduction. The DPL retains the right to approve any and all BC representatives having contact with the Barnwell original material during the reproduction. BC will take proper measures to ensure safety of the original photograph and will be responsible for any damage to the original photograph that might occur during the process of reproduction. DPL also retains the right to approve any BC use of the photograph.

Conditions for sale and marketing of the Barnwell photographic reproductions are outlined below:

1. The BC agrees to market the image in a professional manner.
2. BC further agrees to incur all expenses for reproducing the image, developing the finished product, conducting appropriate promotion and the handling of sales.
3. The photographic reproduction will be offered in three formats: Individual – framed, Individual – unframed, and Deluxe Corporate Edition. A final spreadsheet with detailed expenses and prices will be given to DPL once the reproduction has been produced by BC.
4. For each Barnwell photograph sold by BC, the DPL will receive 25% and the BC will receive 75% of the total revenue. Payment will be made to the DPL at the end of each month.

Millikin University certifies that it may legally enter into this contract, and that the BC lawfully and without restriction represents the interests of the University for the sale and distribution of the Barnwell Lincoln photograph. The BC agrees to sell and distribute the Barnwell photograph as outlined above, and to market the portraits in its print and online catalogs. The BC further agrees to credit the DPL in all public and private promotions of the photograph. The BC also asserts that the photograph will not be copied or altered, either by conventional photography or by digital imaging, without the express, written permission of the DPL.

## Chapter III Personnel

A good public library has at its heart qualified staff who are paid competitive salaries. The staff is well trained through an ongoing program of staff development that includes both in-service training and participation in relevant classes, workshops, and meetings outside the library. Staff have a thorough understanding of all library policies and are able to interpret those policies to library patrons.

The public library has access to the services of a qualified librarian. As first noted in Core Standard 7, "for the purposes of this document, a qualified librarian is one who holds an MLS degree from an ALA-accredited program."

For purposes of this document, a full-time equivalent employee (FTE) works 37.5 hours per week including paid breaks of 15 minutes or less but excluding paid or unpaid meal breaks of 20 minutes or more.

### Applicable Core Standards

- Core 1.** The library provides uniformly gracious and friendly service to all users.
- Core 3.** The library is in compliance with all other state laws that affect library operations including but not limited to the *Illinois Accessibility Code* [ILL. ADMIN. CODE tit. 71, § 400 et seq.], the *Open Meetings Act* [5 ILL. COMP. STAT. ANN. 120/1], the *Illinois Freedom of Information Act* [5 ILL. COMP. STAT. ANN. 140/1 et seq.], the *State Records Act* [5 ILL. COMP. STAT. ANN. 160/1 et seq.; 70/2 and 5/1-7], the *Library Records Confidentiality Act* [75 ILL. COMP. STAT. ANN. 70/1] and the *Drug Free Workplace Act* [30 ILL. COMP. STAT. ANN. 580/1 et seq.].
- Core 4.** The library is in compliance with all federal laws that affect library operations including but not limited to the *Americans with Disabilities Act* [42 U.S.C. 12101 et seq.], the *Fair Labor Standards Act* [29 U.S.C. 201 et seq.] and the *Bloodborne Pathogens Standard* [29 C.F.R. § 1910.1030]. (See appendix 1.)
- Core 7.** The board of trustees appoints a qualified librarian as library administrator and delegates active management of the library to the library administrator [75 ILL. COMP. STAT. ANN. 5/4-7 OR 75 ILL. COMP. STAT. ANN. 16/30-55.35]. For the purposes of this document, a qualified librarian is a person holding an MLS degree from an ALA-accredited program.
- Core 12.** The library has a board-approved mission statement, long-range plan, a disaster prevention and recovery plan, and policies. Such policies include but are not limited to the following topics: personnel; reference; use of the library's materials, services, and facilities including use of the library for exhibits and meetings; and collection management. Illinois statutory law specifically requires the board to establish and review at least biennially a written policy for the selection of library materials (as part of the library's collection management policy) and the use of library materials and facilities [75 ILL. COMP. STAT. ANN. 5/4-7.2 OR 75 ILL. COMP. STAT. ANN. 16/30-60]. All library policies are in compliance with state and federal laws. (See appendix 2.2.)

- 
- Core 16.** The library adopts and adheres to the principles set forth in the American Library Association's Library Bill of Rights and other ALA intellectual freedom statements and interpretations. (See appendices 2.4-2.6 for ALA *Library Bill of Rights* and other ALA intellectual freedom statements.)
- Core 18.** The library adopts and adheres to the ALA *Code of Ethics*. (See Appendix 2.7 for ALA *Code of Ethics*.)
- Core 19.** The library is a member of an Illinois multitype library system and participates in resource sharing through interlibrary loan and reciprocal borrowing.
- Core 24.** The library is open a minimum of 25 hours per week. The hours, scheduled for the convenience of the public include a minimum of two evenings (Total of 6 hours after 5 p.m.) and 4 weekend hours. Branches or other fixed service points, but not bookmobiles, are also open a minimum of 25 hours per week.

### Supplemental Standards

1. To ensure that library staff have a clear understanding of their responsibilities and rights as employees, the library has a board-approved personnel policy. The policy is developed by the library administrator with input from the staff. (See appendix 3.1 for topics recommended for consideration in a personnel policy.)
2. Job descriptions for all positions and a salary schedule are included in the personnel policy or provided elsewhere. Staff members have access to these documents.
3. Personnel policy, job descriptions, and hiring practices are in compliance with the EEOC guidelines and the requirements of the *Americans with Disabilities Act*.
4. Staffing levels are sufficient to carry out the library's mission, develop and implement the library's long-range plan, and provide adequate staff to offer all basic services during all the hours that the library is open. Basic services include circulation and reference. If adult and children's reference or reader's advisory services are offered from two service points, this practice continues during all library hours.
5. Many factors can affect staffing levels. Among these are the layout of the building; the number of staffed public service stations—young adult, AV, computer room, genealogy, and local history; in-house as opposed to municipally-handled payroll and other financial matters; and in-house as opposed to municipally-provided building or grounds maintenance. (See appendix 3.2 for a table of recommended staffing levels.)
6. The library compensates staff in a fair and equitable manner. Salaries alone typically account for up to 60 percent of the total operating budget. Salaries plus fringe benefits (FICA, pension and health insurance) account for up to 70 percent.

The library compensates qualified entry-level librarians with a salary that meets the current recommendation of the Illinois Library Association or at the same rate

received by an entry-level public school teacher with a master's degree, adjusted to reflect a twelve-month work year.

**Example:** In 1996-97, median salary of entry-level public school teacher with masters degree was \$25,079. Divide this amount by 10 and multiply the result by 12.  $\$25,079/10 = \$2,508 \times 12 = \$30,096$ . (The figures were supplied by the Illinois State Board of Education, Research and Policy, 100 North First Street, Springfield, IL 62777-0001, phone 217-782-3950, fax 217-524-7784.)

The library compensates all other staff at a level that is competitive with salaries paid for equivalent positions in other public agencies within the same or approximately the same service area.

7. The library gives each new employee a thorough orientation that introduces the employee to the mission statement, philosophy, goals, and services of the library, as well as to the particular responsibilities of the new employee's job.
8. The library has a performance appraisal system in place that provides staff with an evaluation of current performance and guidance in improving or developing new skills.
9. The library supports and encourages staff to acquire new skills, keep current with new developments in public libraries, and renew their enthusiasm for library work. Attendance at local, state, regional, and national conferences; participation in relevant courses, workshops, seminars, and inservice training; and attendance at local, system, and other library related meetings provide a variety of learning experiences. The library provides paid work time and funding for registration and related expenses. While funding constraints may limit the total number of staff who can attend conferences, the attendance of at least the library administrator at the state library association conference is encouraged and funded.
10. The library provides funding to train staff in the use and maintenance of new technology and equipment.
11. The library provides library journals and other professional literature for the staff.
12. Public library trustees and administrators are aware of federal, state, and local statutes and regulations relevant to personnel administration. Principal regulations include

## STATEMENT OF THE LIBRARY BOARD OF TRUSTEES

A volunteer citizen board governs the policy of the library. The Mission statement of the Library is to provide access to and promote the use of materials that serve the informational, recreational, educational and cultural needs of the community. The Board of Trustees is charged with the responsibility of establishing policy to carry out that mission.

The gift to the community that the library gives is multi-faceted. A modern library is not just a place where one checks out a book to read.

The public that comes through our doors numbers an average of 300,000 plus per year.

Items checked out number over 600,000 plus per year.

We belong to the Rolling Prairie Library System, a consortium of central Illinois medical and educational institutions and public libraries, which broadens access to receive items and research documents delivered to our library within 2 to 3 days.

Also, requests through our Library can broaden a citizen's request to access materials on an international basis.

We maintain reference librarians who field an average 60,000 inquiries per year.

And that is just what traditional libraries do.

In addition, the Decatur Public Library offers a multitude of services. It is truly a cultural center.

Two meeting rooms are offered for a nominal fee and are in almost constant demand.

We may have the largest collection of music, videotapes and DVDs in Macon County.

We have large print books and books on tape or DVDs for individuals with special needs.

We have a large area on the second floor devoted to children, offering all media forms. Within the last year and a half, we have offered 611 programs for children, serving some 15,000 plus children. Some of this was the library's own programming and some was partnering with such entities as Baby Talk, Millikin University and others.

We offer controlled access to research the Internet with 24 computers. We have an online database ranging from automobile repair to antiques to proper test-taking preparation with an additional 11 computers.

In addition, we are a depository of a large number of historical artifacts including the famed Barnwell photo of Lincoln, Firestone plant artifacts and much more that hopefully will be a part of the new cultural center.

Our local history room is the repository of Macon County history, City of Decatur history and many family histories. It is a major resource for historians and genealogists.

We offer classes in computer science on a monthly basis ranging from Computer 101 to advanced skills.

Individual lectures are offered. For example, Guy Fraker spoke on October 25th on *Abraham Lincoln and the Circuit Riding of the 8<sup>th</sup> Judicial Circuit*. Other topics have been as diverse as *An Evening with a Ghost Hunter* to *Dances of the Alexander Hamilton Era*.

In addition to all of that, art and traveling exhibits are presented. The Library partnered with Caterpillar Tractor Co to present a jazz month honoring Ray Charles concluding with a jazz concert, "I Remember Brother Ray" featuring David "Fat Head" Newman. Partnering with Richland Community College, a month-long series studied World War I including the home front and music. There have been many other programs and traveling exhibits and a number of exhibits that only the Decatur Public library was chosen to display in Illinois.

We feel that not only is the Decatur Public Library doing a great job in carrying out its mission but that it is an outstanding asset to the community.

The Board of Trustees is solely responsible for the policy of the Library. Since our City Librarian, Ms. Lee Ann Fisher, came to our Library in 2001, dramatic strides have been made to respond to the community's needs and bring our Library into the 21<sup>st</sup> Century. The decisions made with respect to the Village Mall tenants and the vision of its use are fully the responsibility of the Board of Trustees.

On the issue of the Village Mall, we can only respond to the Council as to what our intent was and the events as we understood them.

We start with the facts. None of the tenants has a lease with the Decatur Public Library. Our board attorney is Ed Booth, but to address this issue we secured the services of an expert in this area, attorney Mark Gibson. His opinion was fully explained to the tenants.

The tenants had leases with Real Estate Investors, LLC, a Cardwell/Randall business enterprise. The Cardwell/Randall enterprise had year-to-year leases with the Library Board for 29 years. It was the original Board's intent to maintain flexibility with respect to the space. The intent was to generate net income while preserving the Library's future use options. Serious breaches of non-payment of rent began to occur from the Cardwell/Randall enterprise. After giving considerable leeway to try to keep all this afloat and save the situation, ultimately the Library had to terminate the lease with the Cardwell/Randall enterprise.

This was done in July 2007. The rights of tenants are derivative from the Cardwell/Randall enterprise. The tenants have leases with Real Estate Investors LLC. The tenants have no leases with the Library.

The Library's agreement with Real Estate Investors LLC was to receive \$40,000.00 per year with no expenses of any kind. No maintenance, no utilities, no taxes.

When the Library received the building back, this situation is what we found:

The tenant population was down to 5 from 10 to 12 spaces available.

There was \$51,814.00 of immediate loss and debt. There was a future tax payment of at least \$17,000.00, payable in 2008.

The building had not been maintained. The immediate need for safety purposes required \$2,223.00 to fix the elevator.

\$17,787.00 had to be spent on the heating and air conditioning unit.

Past rent of \$13,333.32 was owed and lost.

With tax money, the Library had to pay \$18,471.00 in past due real estate taxes for the tax year 2006, payable in 2007. \$17,000 plus in taxes for 2007, payable in 2008, will be assessed and required paid. Only one tenant had a tax account.

All of this caused the Board to take a look at the building with a view toward anticipated future needs.

There was no desire to be a commercial landlord but more importantly there was no desire to have a half-empty building tied to long-term tenancies that would impair our use of the building.

The key was no long-term leases.

The tenants were advised that we would not enter into long-term tenancies. The simple answer seemed to be month-to-month tenancies with the understanding that when and if the Library needed space, we would give the tenants ample lead time of our plans.

There was no intent, desire or need to evict anyone.

That seemed a reasonable solution to the question, but all the tenants apparently did not share it. Some wanted to keep their long-term Cardwell leases and those lease terms.

In the end, this resulted in the September 13<sup>th</sup> letter and the 5 months' lead time to vacate, with a forgiveness of the last 2 months' rent. It was obvious that the tenancies had to be renegotiated.

For example is the lease of the Kate's Café, Bagel & Deli. She had a lease for \$1,500 per month, and by some agreement with a Cardwell representative, received a discount of \$900 per month for cleaning the common areas; thus a net lease payment of \$600 per month. In addition, Kate's Café, Bagel & Deli appears not to pay utilities as all other tenants do. This is still under investigation and we are asking AmerenIP to assist us. We have received two utility bills totaling \$4,227.32 that appear to include the Kate's Café, Bagel & Deli space. These bills the Library must pay. She further makes no payment into a tax account. Kate's Café, Bagel & Deli has insisted on the terms of her Cardwell long-term lease. From all appearances, the Library is losing money on this lease. For the moment, we had decided to let the matter go while the matters sorted out.

We were willing to enter into month-to-month tenancies subject to future needs of the Library. We were not willing to accede to provisions of long-term leases made only with a former landlord, now inoperable because of his default in the lease with the library.

Now as to the rumor as to discussions with the School District and library space. Yes, there have been discussions with the District. The topic has even been noted on some of the School District's meeting agendas. We are not at liberty to reveal their plans and programs, but what we do know is that those plans are a good fit with a library campus.

None of the space being discussed with the School District includes the space of the tenants in the Village Mall.

Our needs for this space is as we see it are:

- The Local History and Cultural Center.
- Just the Cultural Center with the Local History elsewhere.
- Technical Services offices.
- Extension Services.
- Friends of the Library space for Book Store and space for book storage and sorting.
- Meeting rooms.

It was our further hope to utilize the upstairs of the mall building for worthy non-profit charitable organizations.

We intend to use the space for library purposes that marriage with the mission of the Library. The Board fails to see how anyone can disagree with the expansion of a library that gives so much to the community in service and pride. The citizens actually do get their money's worth from the Library. In the United States, every community large and small has free access to a library and knowledge. Decatur not only has the traditional library but a superior library.

Dear Lee Ann:

After the last meeting of the Finance Committee of the Library Board, I feel compelled to write and express my belief in proceeding with caution in dealing with the occupants of the Village Mall. I have expressed concern previously at that meeting about the acceptance of rents and do so again. As I mentioned to you in my initial letter on August 24, 2007, there are some good arguments that can be raised by the occupants of the Mall regarding this situation; in particular, waiver and attornment. Because of the hard line approach being advocated by the Finance Committee, I took the opportunity to go back and review the materials which were provided to me after my initial letter and some additional authority regarding the law in Illinois. My goal is to make sure that we all understand the risks associated with any legal battle and to minimize any loss of public perception for the Library. Also, my goal is to make sure that the Library obtains its goal of receiving the Mall for its use.

The effect of the termination of the primary lease with Real Estate Investors of Decatur, LLC/Central Illinois Real Estate Investments, LLC, does terminate the right of any sub tenants to occupy portions of the Mall. I don't believe there is any question about that. However, the question then becomes what has the Library done since the termination of the primary lease concerning these tenants. As mentioned previously, the inquiry is fact intensive and also in flux as new facts are learned. What was the intent as

to the occupants? As I understood it then and as I understand it now, after the termination of the primary lease, the Library was trying to decide what it wanted to do. It thought that it should make a decision relatively quickly, but in the meantime the occupants of the Mall could stay indefinitely while the Library made its decision. To that end, the Library had Ed Booth contact the occupants and indicate that rents should be paid to the Library and this was followed within a week by a letter from you indicating that the Library would be taking a look at the building and making needed repairs. Unfortunately, nothing was clearly stated in these two letters indicating that the situation was still in flux and while the Library was reviewing its option, that the occupants could pay the rent to the Library. No rents were actually received by the Library until August of 2007.

Subsequently, a meeting of the Mall occupants was held on August 24, 2007 and they were told that the Library was not renewing their leases and was looking at the situation. They were also told that the building was needed for Library use in that the Library was not going to "sell" it. Also at that time it was stated that the Library was looking at putting them on a month to month tenancy. Subsequently, I sent the occupants a letter stating that they could stay as a month to month tenant with a departure date of February 29, 2008. The concern expressed internally about the length of time concerning the occupancy of the tenants was one of real estate tax liability should occupancy go too deep into 2008. No use for the Mall has been determined, although several potential options remain.

I have outlined all of this because I want to make sure that everyone understands that this treading into potential litigation is certainly not a slam dunk. The biggest concern is that a Court may find that an attornment has occurred in this case. An attornment is normally the recognition by a tenant of a new landlord by paying rents to the new landlord. The reason attornment developed was to actually make the tenant liable for additional rents otherwise there was no relationship with the landlord. However, it can also work against the landlord. Such a determination will largely turn on the intent of the parties as previously stated. My understanding is that the Library's intent initially was to preserve the status quo while it determined what it wanted to do. It did not want to just throw out the occupants of the Mall and also in a self serving manner; it needed revenue to meet obligations. Unfortunately, the first two letters to the "tenants" written in July don't say that. They appear to express a desire to keep the tenants around. Additionally, rents were received in early August prior to the meeting in which the actual intent of the Library was clearly expressed. The actual intent of the Library can be explained through testimony, but by just looking at the dry documents a Court may find an attornment has occurred.

If the Court does find attornment occurred then there is some case law, more than one hundred years old, which I believe is still good law in Illinois, which indicates that a year to year tenancy is created. Again, nothing is stated in such an event as to when the year runs, but it most likely would run from July 10<sup>th</sup> to July 9<sup>th</sup>, although it could run from the initial payment of rent or worst case from their sub-lease annual anniversary. There are no cases interpreting this particular case concerning the calculation of the

term. It's just not clear from the cases I have found. The other worst case is, as we know, that the Tenant would get to stay under the term provided in the original sub-lease and perhaps its extensions, if any. I think that is unlikely as there was never any intention expressed as to that.

My intent here is not to cause alarm, but to try to put a better face on why I believe caution in the approach with the Mall occupants would be warranted. I did not clearly articulate this at the Finance Committee meeting. I know also that some members of the Board may be concerned with treating different tenants differently or as being perceived as backing down if the Board accommodates the tenants. I don't see treating the tenants differently as a valid concern. We are dealing with different individuals in each case with different interests and different effects caused by this situation. We now are speaking with them on an individual basis. I think this is the best situation available for the Library. The more tenants that leave the more likely that they all will go. If time is what a tenant wants, you should seriously consider it and not dismiss it because we have indicated that they need to leave by a certain date.

As far as backing down, I see the Board as being wise to keep someone in the building until it determines what it is going to do and when it needs it. Perception of a building sitting empty for several months while no use is made of it would be perceived as a worse situation in my mind. Also, going to Circuit Court to gain the possession of the building and lose would not be good. In which case you may be stuck with the tenant for much longer than you want, suffer a public relations blow, and not get the building for your use. It is worth some time and money to avoid this and the expenses associated with a court battle. Think about how much time is already being spent on this verses a reasonable settlement agreement.

I want you to know that I think that the Library has a good case, but there are always two sides to every story and I want you to know that this other side exists. As I stated previously when one goes to Court, one does not know what a Court may do. I hope you consider what I have stated in this letter as I continue to meet with the tenants and work toward agreeable solutions with each of them to gain the facility for Library use. However, I ask that you be open minded when dealing with these tenants as well in obtaining the goal of gaining possession of the building.

Below we have looked at 4 different options: Print framed inexpensively, unframed, Corporate Limited Edition – 200 with add on values, and Corporate Limited Edition – no frills.

We have estimated a total of 150 prints to be sold by the end of the Lincoln celebration and divided between the 4 alternatives as shown. A proposed advertising budget is shown. Prices for framing, the print and other items are at the moment estimates based on past experiences. If we obtain the Library's permission for this project we will proceed to firm up our numbers.

In terms of revenue splits, you can see that they vary according to the option in question and the number of prints sold. We will be willing to negotiate on those options where the split too heavily favors either BC or the Library. Feel free to use this spread sheet to see how revenue changes if you change price and or add advertising expense.

Ed and I will be willing to meet with you at any time to clarify this or to talk about other possibilities that the Library wants to entertain.

## Chapter III Personnel

A good public library has at its heart qualified staff who are paid competitive salaries. The staff is well trained through an ongoing program of staff development that includes both in-service training and participation in relevant classes, workshops, and meetings outside the library. Staff have a thorough understanding of all library policies and are able to interpret those policies to library patrons.

The public library has access to the services of a qualified librarian. As first noted in Core Standard 7, “for the purposes of this document, a qualified librarian is one who holds an MLS degree from an ALA-accredited program.”

For purposes of this document, a full-time equivalent employee (FTE) works 37.5 hours per week including paid breaks of 15 minutes or less but excluding paid or unpaid meal breaks of 20 minutes or more.

### Applicable Core Standards

- Core 1.** The library provides uniformly gracious and friendly service to all users.
- Core 3.** The library is in compliance with all other state laws that affect library operations including but not limited to the *Illinois Accessibility Code* [ILL. ADMIN. CODE tit. 71, § 400 et seq.], the *Open Meetings Act* [5 ILL. COMP. STAT. ANN. 120/1], the *Illinois Freedom of Information Act* [5 ILL. COMP. STAT. ANN. 140/1 et seq.], the *State Records Act* [5 ILL. COMP. STAT. ANN. 160/1 et seq.; 70/2 and 5/1-7], the *Library Records Confidentiality Act* [75 ILL. COMP. STAT. ANN. 70/1] and the *Drug Free Workplace Act* [30 ILL. COMP. STAT. ANN. 580/1 et seq.].
- Core 4.** The library is in compliance with all federal laws that affect library operations including but not limited to the *Americans with Disabilities Act* [42 U.S.C. 12101 et seq.], the *Fair Labor Standards Act* [29 U.S.C. 201 et seq.] and the *Bloodborne Pathogens Standard* [29 C.F.R. § 1910.1030]. (See appendix 1.)
- Core 7.** The board of trustees appoints a qualified librarian as library administrator and delegates active management of the library to the library administrator [75 ILL. COMP. STAT. ANN. 5/4-7 OR 75 ILL. COMP. STAT. ANN. 16/30-55.35]. For the purposes of this document, a qualified librarian is a person holding an MLS degree from an ALA-accredited program.
- Core 12.** The library has a board-approved mission statement, long-range plan, a disaster prevention and recovery plan, and policies. Such policies include but are not limited to the following topics: personnel; reference; use of the library’s materials, services, and facilities including use of the library for exhibits and meetings; and collection management. Illinois statutory law specifically requires the board to establish and review at least biennially a written policy for the selection of library materials (as part of the library’s collection management policy) and the use of library materials and facilities [75 ILL. COMP. STAT. ANN. 5/4-7.2 OR 75 ILL. COMP. STAT. ANN. 16/30-60]. All library policies are in compliance with state and federal laws. (See appendix 2.2.)

- Core 16.** The library adopts and adheres to the principles set forth in the American Library Association's Library Bill of Rights and other ALA intellectual freedom statements and interpretations. (See appendices 2.4-2.6 for ALA *Library Bill of Rights* and other ALA intellectual freedom statements.)
- Core 18.** The library adopts and adheres to the ALA *Code of Ethics*. (See Appendix 2.7 for ALA *Code of Ethics*.)
- Core 19.** The library is a member of an Illinois multitype library system and participates in resource sharing through interlibrary loan and reciprocal borrowing.
- Core 24.** The library is open a minimum of 25 hours per week. The hours, scheduled for the convenience of the public include a minimum of two evenings (Total of 6 hours after 5 p.m.) and 4 weekend hours. Branches or other fixed service points, but not bookmobiles, are also open a minimum of 25 hours per week.

### Supplemental Standards

1. To ensure that library staff have a clear understanding of their responsibilities and rights as employees, the library has a board-approved personnel policy. The policy is developed by the library administrator with input from the staff. (See appendix 3.1 for topics recommended for consideration in a personnel policy.)
2. Job descriptions for all positions and a salary schedule are included in the personnel policy or provided elsewhere. Staff members have access to these documents.
3. Personnel policy, job descriptions, and hiring practices are in compliance with the EEOC guidelines and the requirements of the *Americans with Disabilities Act*.
4. Staffing levels are sufficient to carry out the library's mission, develop and implement the library's long-range plan, and provide adequate staff to offer all basic services during all the hours that the library is open. Basic services include circulation and reference. If adult and children's reference or reader's advisory services are offered from two service points, this practice continues during all library hours.
5. Many factors can affect staffing levels. Among these are the layout of the building; the number of staffed public service stations—young adult, AV, computer room, genealogy, and local history; in-house as opposed to municipally-handled payroll and other financial matters; and in-house as opposed to municipally-provided building or grounds maintenance. (See appendix 3.2 for a table of recommended staffing levels.)
6. The library compensates staff in a fair and equitable manner. Salaries alone typically account for up to 60 percent of the total operating budget. Salaries plus fringe benefits (FICA, pension and health insurance) account for up to 70 percent.

The library compensates qualified entry-level librarians with a salary that meets the current recommendation of the Illinois Library Association or at the same rate

received by an entry-level public school teacher with a master's degree, adjusted to reflect a twelve-month work year.

**Example:** In 1996-97, median salary of entry-level public school teacher with masters degree was \$25,079. Divide this amount by 10 and multiply the result by 12.  $\$25,079/10 = \$2,508 \times 12 = \$30,096$ . (The figures were supplied by the Illinois State Board of Education, Research and Policy, 100 North First Street, Springfield, IL 62777-0001, phone 217-782-3950, fax 217-524-7784.)

The library compensates all other staff at a level that is competitive with salaries paid for equivalent positions in other public agencies within the same or approximately the same service area.

7. The library gives each new employee a thorough orientation that introduces the employee to the mission statement, philosophy, goals, and services of the library, as well as to the particular responsibilities of the new employee's job.
8. The library has a performance appraisal system in place that provides staff with an evaluation of current performance and guidance in improving or developing new skills.
9. The library supports and encourages staff to acquire new skills, keep current with new developments in public libraries, and renew their enthusiasm for library work. Attendance at local, state, regional, and national conferences; participation in relevant courses, workshops, seminars, and inservice training; and attendance at local, system, and other library related meetings provide a variety of learning experiences. The library provides paid work time and funding for registration and related expenses. While funding constraints may limit the total number of staff who can attend conferences, the attendance of at least the library administrator at the state library association conference is encouraged and funded.
10. The library provides funding to train staff in the use and maintenance of new technology and equipment.
11. The library provides library journals and other professional literature for the staff.
12. Public library trustees and administrators are aware of federal, state, and local statutes and regulations relevant to personnel administration. Principal regulations include
